#### Site Description and History

The former Lake Ontario Ordnance Works (LOOW) is located approximately 10 miles north of the City of Niagara Falls within the Towns of Lewiston and Porter in Niagara County, New York.

The original site encompassed approximately 7,500 acres and was established in 1942. A portion of LOOW, consisting of 6,500 acres, is eligible for inclusion in the Department of Defense (DoD) Defense Environmental Restoration Program for Formerly Used Defense Sites (DERP-FUDS). During World War II, the U.S. Army built and operated a trinitrotoluene (TNT) plant on approximately 2,500 acres of the site, known as the developed zone. The remaining 5,000-acre undeveloped zone served as a buffer area around the TNT plant. The plant manufactured bulk TNT for approximately nine months and was decommissioned in 1943. The Corps of Engineers (Corps) is conducting an environmental investigation on the former LOOW in accordance with the phased Comprehensive Environmental Response, Compensation and Liability Act (CERCLA).

#### Management Action Plan

Due to the size of the former LOOW, the number of current real estate tax parcels (over 550), and the variability in site use (e.g., from a school to a Subtitle C landfill), the planning, funding, and execution of environmental response activities (including closure of those areas not adversely impacted by federal activities) has been challenging. The purpose of the LOOW Management Action Plan (MAP) is to integrate and evaluate information from prior Corps reports and relevant non-Corps sources to establish a single comprehensive agency planning document in which the Corps formally communicates findings, conclusions, and a framework to achieve the objectives of the Corps' CERCLA responsibilities at the former LOOW for each parcel group.

For the MAP, a parcel group is defined as a single parcel or multiple parcels with similar characteristics with regard to FUDS property eligibility, location relative to the developed area of LOOW, ownership, known or suspected DoD impacts, and land use. It is the unit for which each Property Management Action Plan (PMAP) was developed and for which findings, conclusions,

and strategies for eventual closure are presented. The over 550 parcels that comprise the former LOOW have been divided into separate parcel groups, which are shown in Figure 1.

The LOOW MAP is not intended to replace or serve as a formal CERCLA decision document, but rather as a planning document with an anticipated path forward for completion of the DERP-FUDS mission at the property parcels comprising the former LOOW.

The MAP presents: objectives; methodologies; Corps and other federal, state, and local agency authority and responsibilities; summary of findings and strategy; and explains why and how each of the real property parcels, defined by the Niagara County Department of Real Property, were combined into parcel groups.

The MAP is a "living" document that is updated when a significant change in strategy or status from the previous submittal has occurred. The MAP and associated PMAPs were originally published in October 2009, updated in February 2013 (Update 1), and updated in May 2015 (Update 2). Within the MAP and PMAPs, changes from the previous version are highlighted and outlined to allow the reader easy access to updated information. This fact sheet presents a summary of the key changes that occurred in Updates 1 and 2 as presented below.

#### February 2013 MAP and PMAPs, Update 1

The MAP and all associated PMAPs were revised and published in February 2013 for Update 1. Property boundaries were updated to reflect the Niagara County Department of Real Property Tax 2010 records, and information from a number of documents, listed below, was incorporated into the PMAPs.

At that time, 21 parcel groups had a status of response complete (No DoD Action Indicated or NDAI), nine parcel groups required further evaluation of hazards or potential hazards, two parcel groups were ineligible for investigation under DERP-FUDS, and one parcel group was being investigated under the Formerly Utilized Sites Remedial Action Program (FUSRAP) rather than DERP-FUDS.

May 2015 MAP and PMAPs, Update 2

The MAP and 12 associated PMAPs were revised and published in May 2015 for Update 2. These PMAPs were revised because new information became available from a number of documents. The 12 PMAPs that were updated, and the relevant documents are:

The current status of the environmental investigations on the former LOOW, as reflected in the May 2015 MAP update, is summarized below and in Table 1 for each parcel group:

- Twenty-eight parcel groups had a status of Response Complete, NDAI.
- Two Parcel groups are active/ongoing and require further evaluation of hazards or potential hazards.
- Two parcel groups were ineligible for investigation under DERP-FUDS because they were currently owned by the U.S. government or were transferred from DoD ownership after 17 October 1986.
- One parcel group is being investigated under FUSRAP rather than DERP-FUDS.
