This Department has reviewed the Notice of Intent form that was submitted for renewal of coverage under the Multi-Sector General Permit for Stormwater Discharges Associated with Industrial Activity (GP-0-06-002) on behalf of the above facility and has determined that coverage under this permit is not required.

Please note that this facility previously obtained coverage under the SPDES General Permit for Stormwater Discharges Associated with Industrial Activity (GP-98-03) for a facility conducting activities listed under Sector L. Based on information communicated by Michelle Rhodes, NFSS Project Engineer, it has been determined that this facility has been closed in accordance with Department regulations and that no waste materials are currently exposed to stormwater. Therefore, the facility's activities are not included in the 40 CFR 122.26(b)(14) definition of activities requiring SPDES permit coverage for stormwater discharges.

Michelle Rhodes gave verbal consent to change the *reason for submittal* (Item 2) on the Notice of Intent or Termination (NOIT) from *renewal* to *termination*.
