Bill,

Personally, I understand that DERP-FUDS and FUSRAP define the scope of the USACE involvement.

Relating to your question, I would like to have the USACE be more visible, and deliberate, in including the LOOW RAB in the intercommunication with other agencies on any issue the goes beyond that definition.
