Walt is correct. The USACE request for public input for the latest technical memorandum "Potential Health Effects of Contaminants at the IWCS" is not a genuine solicitation. It comes ahead of our being told what's in the IWCS. How can we submit meaningful comment when we don't even have the inventory of the contents of the IWCS? (The inventory is to be released sometime in the future, as part of the RI Addendum report.)

I believe we are wrong in endorsing USACE going ahead with the Feasibility Study, before releasing all of the data from the RI and RI Addendum. I have no confidence in a process which keeps us and the public in the dark. USACE is pushing ahead, while effectively blocking public input. We should call for a halt to the Feasibility Study until USACE gives us and the rest of the public all of the available RI data.

Having scanned through the latest USACE offering, I note there is mention of a new onsite cell and short-term effectiveness of remedial action. Has USACE mentioned this before? I firmly believe the IWCS is leaking - the limited data we do have shows 1,000pCi/L of uranium in the groundwater south and east of the IWCS (background according to USACE is around 10pCi/L.)
