We are sending this to you on behalf of the U.S. Department of Energy.

The U.S. Department of Energy has posted the desktop evaluation of the radiological cleanup of several closed vicinity properties at the Niagara Falls Storage Site.

The "Niagara Falls Storage Site Vicinity Properties, New York: Review of Radiological Conditions at Six Vicinity Properties and Two Drainage Ditches" report is available on the Office of Legacy Management webpage at:

Stakeholder concerns about final conditions at certain Niagara Falls Storage Site Vicinity Properties (VP) prompted DOE to respond to the community with a detailed data review of six selected VPs (VP-Q, VP-R, VP-S, VP-T, VP-W, and VP-X) and associated drainages for which DOE completed remediation activities under the Formerly Utilized Sites Remedial Action Program (FUSRAP).

A preliminary report was made available for public review and comment on March 19, 2010 and comments were accepted through June 14. DOE considered all public comments in finalizing the report and included a responsiveness summary addressing all comments in an attachment to the final report. The report also contains a bibliography of all documents reviewed.

This report is not a decision document nor a regulatory requirement and is based on documentation and records currently available to DOE. In the event that additional information becomes available, DOE will revisit the report and revise its conclusions as is warranted.

DOE continues to encourage stakeholders to provide information at any time that they might have concerning the Niagara Falls Storage Site VPs.

DOE will address any questions from the public about the report and its conclusions during the poster session and roundtable discussion during the U.S. Army Corps of Engineers Lake Ontario Ordinance Works (LOOW) Site and the Niagara Falls Storage Site (NFSS) public workshop on Wednesday, Nov. 3, 2010, from 6 to 9 p.m. in the Lewiston Senior Center, 4361 Lower River Road, Youngstown, NY 14174.
