#### Town of Tonawanda – Department of Water Resources

The Town of Tonawanda is the owner and manager of the Tonawanda Landfill. The Town is required to close the Landfill in accordance with the New York State Part 360 Solid Waste Management Facility Regulations. For the past year, the Town has been working to place additional, select waste in the landfill to

#### New York State Department of Environmental Conservation

The closure of the Tonawanda Landfill is subject to NYSDEC's review and approval of the Town's Landfill Closure Plan. NYSDEC is also working with the Town to address recent odor problems, and to address the Landfill wastes contaminated by

#### U.S. Army Corps of Engineers (USACE) – Buffalo District

The Corps has been investigating the Tonawanda Landfill as part of its mission under the Federal "Formerly Utilized Sites Remedial Action Program" (FUSRAP) to investigate sites that may have been used during the Nation's early atomic energy Program. The Corps only investigated for those contaminants that may be

related to the historic Manhattan Project activities; Uranium, Thorium and Radium. The Corps released the results of its investigation in 2006 and now has published the Proposed Plan for the Site in order to collect public comment regarding the Plan.
