#### C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

**B. ADDITIONAL COMMENTS TO SUPPORT JD:** The perimeter of the enire 0.04 acre Wetland 1 and 0.04 acre Wetland 2 were walked on the date of the site visit (October 19, 2015), it was determined that Wetlands 1 and 2 are depressional wetlands and lacked any connections to any waters, including no potential for shallow subsurface flow. Based on on-site observations and topographic map, the area on the site and surrounding the site is predominantly flat. There was no road side stormwater channel present on the side of the site along Smith Street (west side of Smith Street). Wetland 1 was measured to be over 280 linear feet north from the nearest Unnamed Tributary (off site) to Eighteenmile Creek. Wetland 2 was measured to be located more than 250 linear feet north from the Unnamed Tributary (off site) to Eighteenmile Creek. Wetlands 1 and 2 were 25 percent inundated on the day of the site visit (10/19/2015), and on examination do not appear to have the potential to support spawning of water dependant animals, as the site does not provide easy access for water dependent species. Based on historic arials obtained from Google Earth Pro it was assertained that the site was previously used for agriculture, and the wetlands may have originated as a result of plowing. Wetlands 1 and 2 are outside Department of the Army jurisdiction as they do not meet the criteria for a jurisdictional waters of the United States according to 33 CFR Part 328.3(a)(1-7) as follows:

1. do not/have not supported interstate or foreign commerce;

2. are not interstate water/wetlands;
3. the degradation or destruction of which would not affect interstate or foreign commerce and does not include such waters:
(i) which are or could be used by interstate or foreign travelers for recreational or other purposes; or
(ii) from which fish or shellfish are or could be taken and sold in interstate or foreign commerce; or
(iii) which are used or could be used for industrial purpose by industries in interstate commerce
4. are not impoundments of water otherwise defined as WOUS under the definition;
5. are not tributaries of waters identified in paragraphs (a)(1)-(4) of this section;
6. are not territorial seas;
$7. \ \ are not wetlands adjacent to waters (other than waters that are themselves wetlands) identified in paragraphs (a) (1)-(6) of this section.$




