## Condition of Federal Navigation Channel Cleveland harbor - Cuyahoga River, Ohio

1. Condition surveys performed within the Federal Navigation Channel at Cleveland harbor - Cuyahoga River, Ohio during the month of April 2019 indicate shoaling has reduced depths to those shown on the attached standard tabular form and channel condition drawings.
2. Soundings are in feet and referred to Low Water Datum (LWD) 569.2 feet above Mean Water Level (MWL) at Rimouski, Quebec (International Great Lakes Datum 1985).
3. Vessel operators are advised to use caution when navigating in this area.
4. Copies of the sounding print for Cleveland harbor - Cuyahoga River, Ohio consisting of (5) sheets, Cyr19VH101 thru 105, at a cost of \$2.50 per sheet will be furnished upon receipt of a check in the full amount made payable to: USACE Finance and Accounting. 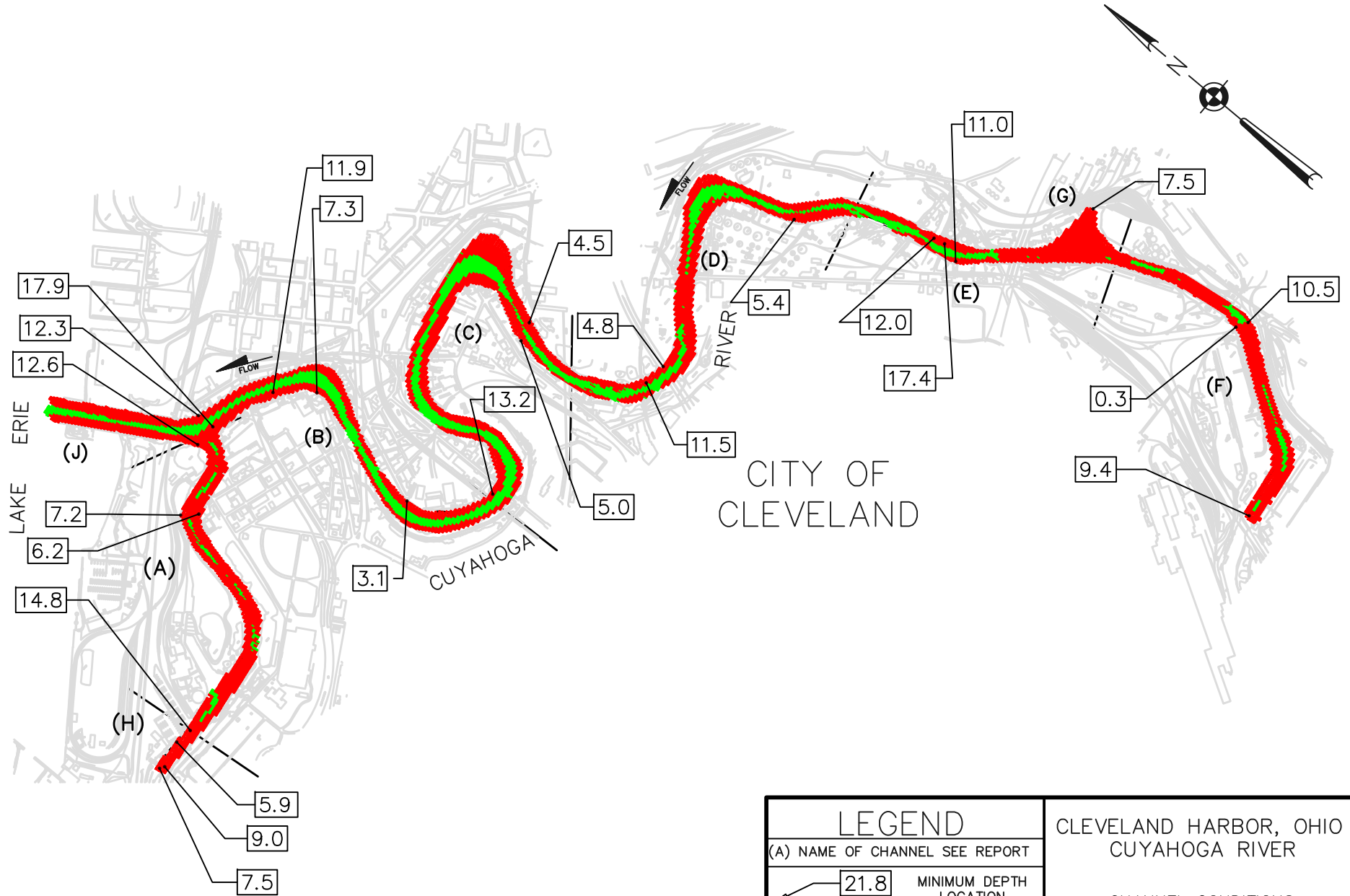
