The agencies will assert jurisdiction over non-navigable tributaries of TNWs where the tributaries are "relatively permanent waters" (RPWs), i.e. tributaries that typically flow year-round or have continuous flow at least seasonally (e.g., typically 3 months). A wetland that is adjacent to but that does not directly abut an RPW requires a significant nexus evaluation. There is also a non-jurisdictional swale located on the west side of Wetland B, between 6047 and 6059 Ruple Parkway, that transports water from the wetland to a catch basin located along Ruple Parkway. The catch basin connects to the storm sewer system flowing north, crossing Ruple Parkway, and then emptying into the East Branch Rocky River. The East Branch Rocky River connects with the West Branch to form the main branch of the Rocky River, which is a TNW further downstream.

Summarize overall biological, chemical and physical functions being performed: The wetlands provide the following functions and services: hydrologic flux and storage including floodwater and runoff attenuation and release; sediment and nutrient transport and retention; pollutant attenuation and release; biogeochemical cycling and storage; stream channel stability via serving as a natural buffer; biological productivity of micro/macro flora and fauna, decomposition, and community structure; and wildlife support including providing habitat.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Draw connections between the features documented and the effects on the TNW, as identified in the *Rapanos* Guidance and discussed in the Instructional Guidebook. Factors to consider include, for example:

- Does the tributary, in combination with its adjacent wetlands (if any), have the capacity to carry pollutants or flood waters to TNWs, or to reduce the amount of pollutants or flood waters reaching a TNW?
- Does the tributary, in combination with its adjacent wetlands (if any), provide habitat and lifecycle support functions for fish and other species, such as feeding, nesting, spawning, or rearing young for species that are present in the TNW?

- Does the tributary, in combination with its adjacent wetlands (if any), have other relationships to the physical, chemical, or biological integrity of the TNW?

1. **Significant nexus findings for non-RPW that has no adjacent wetlands and flows directly or indirectly into TNWs.** Explain findings of presence or absence of significant nexus below, based on the tributary itself, then go to Section III.D: 7T

3. **Significant nexus findings for wetlands adjacent to an RPW but that do not directly abut the RPW.** Explain findings of presence or absence of significant nexus below, based on the tributary in combination with all of its adjacent wetlands, then go to Section III.D: Water from Wetland B flows through an off-site non-jurisdictional drainageway, located along the north side of the wetland, to the east into a storm sewer. Resources provided by the City Engineer show the storm sewer discharging into Abrams Creek, a perennial RPW located to the east of the review area, that flows north into the Rocky River. There is also a non-jurisdictional swale located on the west side of Wetland B, between 6047 and 6059 Ruple Parkway, that transports water from the wetland to a catch basin located along Ruple Parkway. The catch basin connects to the storm sewer system flowing north, crossing Ruple Parkway, and then emptying into the East Branch Rocky River. The East Branch Rocky River connects with the West Branch to form the main branch of the Rocky River, which is a TNW further downstream. The wetland stores runoff, filter pollutants, and settles sediment that would otherwise be transported to the downstream TNW. Sources of impairment within the Rocky River watershed include land development, urbanization, suburbanization, urban runoff, and storm sewers. Since the wetland is located in close proximity to commercial development and receives a majority of its hydrology from precipitation and runoff associated with the adjacent development and roadway, it provides an important function of reducing the effects of runoff and storm sewer impacts on the downstream TNW. The wetland supplies the downstream TNW with a cleaner source of water that will aid in reducing impairments.
