Explain: **Wetland B is a 0.11-acre forested depressional area that is entirely surrounded by upland. While this area meets the definition of wetland, the hydric soil indicator that was met (F3) was marginal. This area is located in a pasture often frequented**

by cows. It appears that this wetland may have developed over time because of soil compaction by cows. Wetland B is outside Department of the Army jurisdiction as it does not meet the criteria for a jurisdictional water of the United States according to 33 CFR Part 328.3(a)(1-8) as follows:

- (1) does not/has not supported interstate or foreign commerce; Wetland B does not provide any ecological interconnect to downstream waters and is not confined by a berm, dam, or obstruction other than topography. As described above, Wetland B is a small depressional area entirely surrounded by upland. It has no surface water connection to a downstream water. Soils in that area are mapped as Collamer soil series, which is classified as upland. Onsite investigation did not reveal soils with significant amounts of organic matter, indicating that subsurface flow would not be present. Soils were found to be compacted, probably due to the presence of cows; therefore subsurface flow connection to a downstream water is very unlikely.
- (2) is not an interstate water/wetland; Wetland B does not cross state boundaries;
- (3) the degradation or destruction of which would not affect interstate or foreign commerce and does not include such waters:
 - (i) which is or could be used by interstate or foreign travelers for recreational or other purposes; or
 - (ii) from which fish or shellfish are or could be taken and sold in interstate or foreign commerce; or
 - (iii) which is used or could be used for industrial purpose by industries in interstate commerce

Wetland B cannot be used by interstate or foreign travelers for recreational or other purposes, fish or shellfish; cannot be taken and sold in interstate or foreign commerce; and could not be used for industrial purposes by industries in interstate commerce;

- (4) is not an impoundment of water otherwise defined as WOUS under the definition;
- (5) is not a tributary of waters identified in paragraphs (a)(1)-(4) of this section; Wetland B is surrounded by upland field and is not adjacent to a stream.
- (6) is not a territorial sea;
- (7) is not wetland adjacent to waters (other than waters that are themselves wetlands) identified in paragraphs (a)(1)-(6) of this section; see paragraph (5) above.

Wetland B is located approximately 200 feet from another wetland (Wetland A) located on the property but outside of the review area for this JD and approximately 1,600 feet from the nearest mapped perennial stream. Based on a clear aerial view obtained on Google Earth Pro (dated 4/29/2006), Wetland B is also located approximately 800 feet from a channel associated with Wetland A and which is located outside of the review area. Wetland does not appear to have any ecological continuum with the Wetland A stream channel.

If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. **SIGNIFICANT NEXUS DETERMINATION**

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Draw connections between the features documented and the effects on the TNW, as identified in the *Rapanos* Guidance and discussed in the Instructional Guidebook. Factors to consider include, for example:
