C. PROJECT LOCATION AND BACKGROUND INFORMATION: The 100-acre site is proposed for the expansion of a gravel mining operation known as the Panther Lake Mine #70993. The parcel is located within vacant rural land within a rural residential area and is west of Whipple Road and northwest of its intersection with County Route 17.

Check if other sites: Wetlands A and B were processed under the Preliminary Jurisdiction process which was completed on April 7, 2014. A connection was identified between the two areas delineated by Ingalls as Wetland B. The summary report indicated that approximately 15.2 acres is dually regulated by the USACE and the NYSDEC and 1.6 acres would be regulated by the USACE only, and that Wetland A (2.66 acres) and Wetland ED were determined to be isolated.

As a result of on-site observations and a review of the Oneida County Soil Survey map, the USACE determined that Wetland A is actually part of the Wetland B complex. A haul road recently constructed through the drainage/stream from Wetland A to Wetland B impedes downstream flow; however, the edge of Wetland A is no more than 8-10 feet away from the area flagged as Wetland B.

The soil map shows a clearly marked stream through the area flagged as Wetland A to the segment flagged as Wetland B. Further, the entire wetland complex exhibits Rifle muck, which is classified as hydric. However, the actual stream in Wetland A was not discernible because the water was high and it wasn't feasible to try to measure linear feet. Approximately 820 linear feet of stream was evident from the east side of the haul road through a portion of Wetland B and then disappears within the large and deep wetland complex.

Wetland ED (0.11 acre – PFO) is located near the northwestern corner of the property in a depressional area on a forested hill top (Review Area 2). According to the delineation report, at the time of the delineation, there were approximately 3-inches of standing water in the wetland, but no evidence of any streams, drainages, or other conveyances of flow from Wetland ED to downstream waters. The nearest possible connection would be Wetlands A and B, which are approximately 840 feet southeast of Wetland ED. This distance is comprised of upland forest in a steep, hilly terrain. The source of hydrology is precipitation and the potential for groundwater influence is not apparent. Collected water infiltrates or evaporates. Although small, the wetland's location within the forested landscape likely provides life-cycle habitat for amphibians, as well as general use by mammals and migratory birds typical of the area.

This wetland is located within an area mapped as Colton-Hinckley soils. This is a moderately steep soil found on the sides of terraces, elongated ridges and kame-like hills with complex slopes with drainage ranging from excessively well drained to moderately well drained. Slopes range from 25-35% and individual areas vary in shape and may be 5-20 acres in size. These soils are an excellent source of sand and gravel and are prone to erosion when vegetation is removed.

Wetland 1 is not a component of an ecological continuum and does not contribute to characteristics that would influence the physical, chemical, and biological integrity of downstream waters. Topographic relief does not indicate the presence of swales or other drainages sloping down the hilltop that would carry hydrology to Stream 1, which is the nearest conveyance. Further, due to topography and distance to the nearest tributary, the presence of a shallow subsurface flow connection is very unlikely.

Wetland ED is depicted as REVIEW AREA 2 on the attached map. Aquatic resources shown in REVIEW AREA 1 will be processed as a Preliminary Jurisdictional Determination.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD:

A site visit was conducted on June 13, 2013. On-site observations and supplemental information provided by Ingalls and Associates substantiate determination that Wetland ED is not a component of an ecological continuum and does not contribute to characteristics that would influence the physical, chemical, and biological integrity of downstream waters. Topographic relief does not indicate the presence of swales or other drainages sloping down the hilltop that would carry hydrology to Stream 1, which is the nearest conveyance. Further, due to topography and distance to the nearest tributary, the presence of a shallow subsurface flow connection is very unlikely.
