Summarize overall biological, chemical and physical functions being performed: The wetlands store runoff, filter pollutants, and settle sediment typically associated with farming practices.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Draw connections between the features documented and the effects on the TNW, as identified in the *Rapanos* Guidance and discussed in the Instructional Guidebook. Factors to consider include, for example:

- Does the tributary, in combination with its adjacent wetlands (if any), have other relationships to the physical, chemical, or biological integrity of the TNW?

According to the Ohio Environmental Protection Agency (OEPA), sources of impairment within the Rocky River watershed include land development, urbanization, suburbanization, urban runoff, and storm sewers (*Total Maximum Daily Loads for Bacteria in the Rocky River Watershed*, OEPA Division of Water Quality, Draft Report March 2005). In addition, the OEPA indicates that run off associated with farming practices is a smaller, but nonetheless, important source of impairment. Since the wetlands are located within farm fields and vineyards, and receive a majority of their hydrology from runoff associated with the associated farming practices it provides an important function of reducing the effects of stormwater runoff impacts on the downstream TNW. The wetlands store stormwater runoff, and ultimately supply the downstream TNW with a cleaner source of water that will aid in reducing impairments.
