Explain: A site visit conducted on June 2, 2014 revealed Wetland B (0.08 acres), Wetland C (0.45 acres), Wetland E (0.09 acres) and Wetland F (0.04 acres) have no potential to affect interstate commerce under 328.3(a)(3)(i-iii) (See Section IVB of this form). Wetland B,

C, E, and F are each less than ½ acre in size and not located near any water of the U.S. The closest water of the U.S. is the unnamed tributary to Red Creek which is over 400 feet from any of these isolated wetlands. Upland areas separate these isolated wetlands eliminating ecological continuum between these wetlands and other waters of the U.S. No shallow subsurface connections from these isolated wetlands to other waters were observed. These small, hydrologically isolated wetlands located a significant distance from a RPW prohibit them from having no more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a water of the U.S. Therefore, Wetland B, C, E, and F do not meet the criteria for a jurisdictional water of the U.S. and are considered to be intrastate, non-navigable, isolated waters.

If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Draw connections between the features documented and the effects on the TNW, as identified in the *Rapanos* Guidance and discussed in the Instructional Guidebook. Factors to consider include, for example:

Wetland A is located along both banks of this RPW along the entire length of the RPW. Wetland A completely engulfs the RPW on the subject site. No impediments to flow exist between Wetland A and the RPW. Wetland A and the RPW work together to move flows through the site and have a clear hydrologic connection.

Wetland D is the northwest corner of a larger wetland complex that continues east beyond the parcel boundary all the way to the RPW. Wetland D and Wetland A are part of the same scrub-shrub/forested floodplain wetland that abuts the RPW. This entire wetland complex engulfs the RPW and discharges flows directly into the RPW. No hydrologic impediments to flow exist between the RPW and its abutting floodplain wetlands D and A which are part of a larger floodplain wetland complex that continues beyond the borders of the subject parcel.
