C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

As stated in the delineation report dated July 2014, due to the disturbed nature of the site (agricultural fields), obvious wetlands outside but adjacent to the project area were utilized as reference to compare the saturated pockets found within the fields. Using the Munsell soil chart, soil in the reference sites keyed as 7.5YR 4/2 with the upland areas characterized as 7.5YR 4/4 and 10YR 5/4. The area mapped on the NWI (Depressional Area #1 below) keyed as 10YR 5/4, which indicates that hydrology within the depression is not persisting long enough to establish hydric soil conditions. The non-mapped depressional areas within the project area keyed as 7.5YR 4/4 and 7.5YR 5/4.

B. ADDITIONAL COMMENTS TO SUPPORT JD:

On-site observations were consistent with the delineation report which states that no wetlands or streams were identified within the project parcel. This land parcel has been in active agriculture for many years and does not have drain tiles. Although the Tioga NWI Map indicates a mapped wetland within the project area (Depressional Area 1), on-site observations indicate a small (0.001 acre) depressional area at that location. It is possible that this depressional area contained standing water at the time the site was flown. However, as described in "Soils" above, analysis of soil characteristics indicates that saturation has not persisted for a duration long enough to facilitate development of hydric soil characteristics. Further, the delineation report identified two (2) additional depressional areas, each approximately 0.001 acre. Soil sample pits indicate that soils do not meet the required criteria to be identified as hydric soils. It is evident that all three (3) of the depressional areas become saturated after rain events and retain standing water when the Susquehanna River overtops its banks. Row crops do not establish in these areas and wetland vegetation was not observed.
