- Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional.
Explain: Wetland 1 (0.16-acre) and Wetland 2 (1.4 acres) were determined to be isolated. The factors at 328.3(a)(i-iii) were considered and there is no substantial nexus to interstate or foreign commerce. Based on aerial photos over the decades, it appears these wetlands are depressions with no inlets or outlets. The entire perimeter of each wetland was walked by Heather Adams and Joe Rowley. The wetlands are surrounded by a road, an old railroad bed and paved areas with buildings, all of which are a few to several feet higher than the elevation of the wetlands. No culverts or other type of swale or possible drainage area was found and no surface water connection to other wetlands

or a stream could be discerned. The wetlands are not mapped on the NWI and are not within the 100 year flood zone. Although the wetlands are about 200 feet from Buffalo Creek, any hydrological or chemical movement from the wetland to the tributary and TNW would be unlikely.

This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Draw connections between the features documented and the effects on the TNW, as identified in the *Rapanos* Guidance and discussed in the Instructional Guidebook. Factors to consider include, for example:

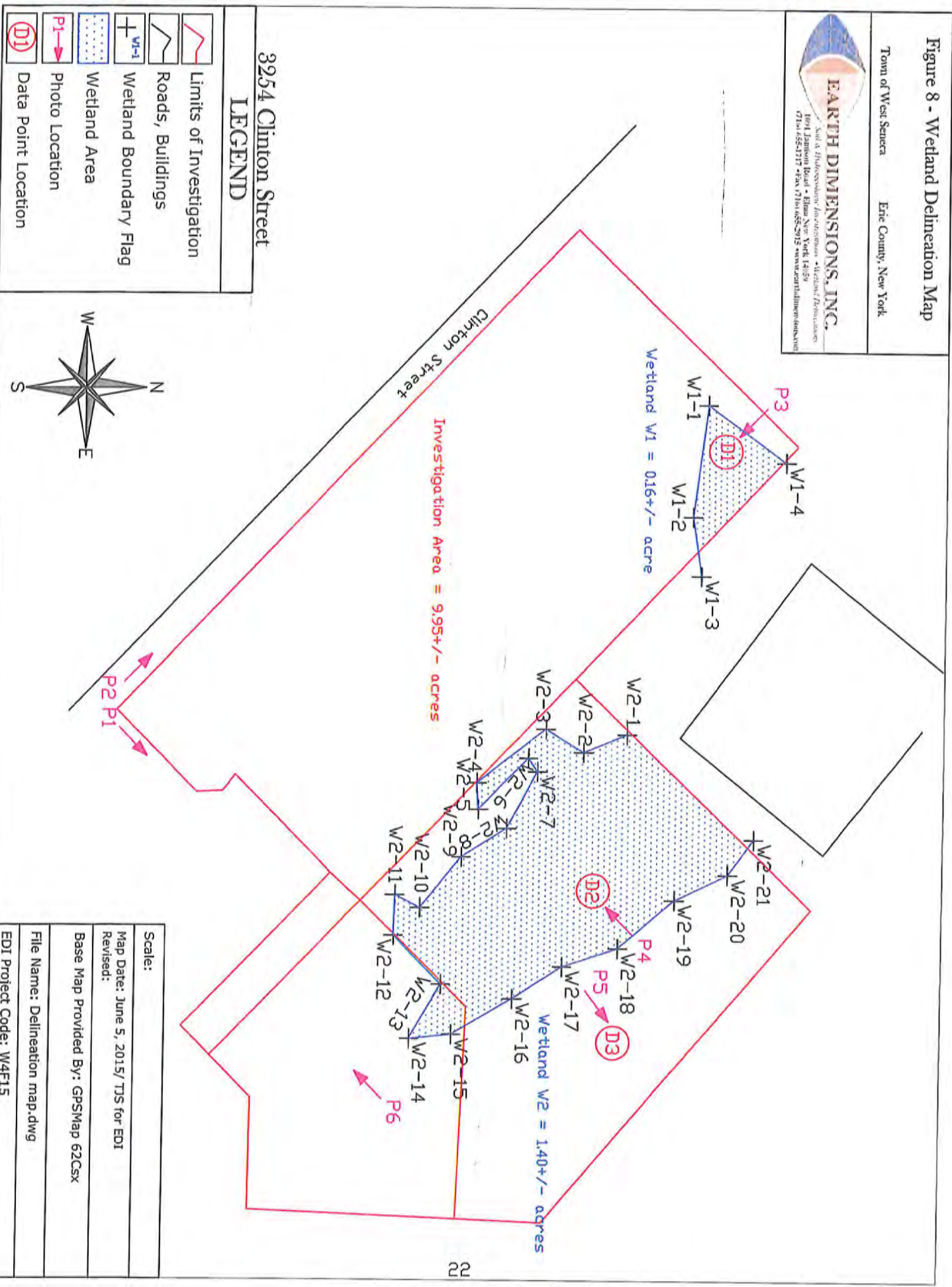

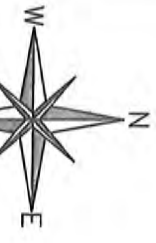
