Explain: **I conducted a site visit on August 19, 2015 and also reviewed in-house resources including, topographical**

maps, aerial photography and soils maps. I walked the perimeters of Wetland 2 (0.74 acres), Wetland 3 (0.35),

Wetland 4 (0.56), Wetland 5 (0.12), Wetland 6 (0.44), Wetland 7 (0.44), Wetland 8 (0.34), Wetland 9 (0.17), Wetland 10

(0.12), and Wetland 11 (0.03). No surface flow drainage of any type or culverts going away from Wetlands 2-11 were identified. No shallow subsurface connections were identified. Wetlands 2-11 do not appear to have an ecological nexus to the Niagara River, a TNW located off-site. Wetlands 2-11 do not contain the same type of habitat as Wetland 1 or the Niagara River. Wetlands 2-11 are all located within an area that has been previously identified and well documented to be impacted in the past through cut and fill activities. The area where these wetlands exist has been used for dredged and excavated material placement during the creation of the adjacent roadway and marina and for other more recent uses. The area has also been excavated and manipulated for fill for use off-site. No ecological continuum is apparent between these wetlands and the Niagara River or Wetland 1. There is significant evidence that Wetlands 2-11 do not support the same types of habitat or wildlife species as the Niagara River or Wetland 1. They are a result of previous filling and excavating. Some may hold water after snow melt, however there is no indication that surface water hydrology or shallow subsurface water water is conveyed into Wetland 1 and into the Niagara River. Wetland (0.17 acres) is approximately 700 linear feet from the Niagara River (closest of the wetlands to the river) and Wetland 8 (0.34 acres) is approximately 1500 linear feet from the Niagara River (furthest of the wetlands from the Niagara River). Due to fill and natural topography, these wetlands are located approximately 15-20 feet higher in the landscape compared with Wetland 1. All of these wetlands are geographically isolated with no ecological continuum to Wetland 1 and the Niagara River and therefore are not not jurisdictional waters of the U.S.

SECTION III: CWA ANALYSIS

A. TNWs AND WETLANDS ADJACENT TO TNWs

The agencies will assert jurisdiction over TNWs and wetlands adjacent to TNWs. 1. TNW

Identify TNW: **Niagara River.** The Niagara River, a TNW, is approximately 150 linear feet at its closest point to Wetland 1. The river is topographically separated from Wetland 1 by elevated fill placed for a roadway and commercial development. However, surface water hydrology is conveyed directly from Wetland 1 on the subject parcel to the Niagara River via an approximately 20-inch culvert. The TNW is not located on the parcel in review but is significant to the jurisdiction of Wetland 1 located on site.

Summarize rationale supporting determination: The Niagara River has previously been determined to be a TNW, however the Niagara River is located off-site and is approximately 150 linear feet from Wetland 1.

2. Wetland adjacent to TNW

Summarize rationale supporting conclusion that wetland is “adjacent”: As indicated above, Wetland 1 is approximately 150 linear feet at its closest point to the TNW. Wetland 1 is topographically separated from the river by elevated fill placed for a roadway and commercial development. Surface water hydrology is conveyed directly from Wetland 1 on the subject parcel to the Niagara River via an approximately 20-inch culvert. Verified hydrological connection to the river, landscape position, and in-house resource reviews supports that Wetland 1 was directly connected to the Niagara River prior to placement of fill for the roadway, home and commercial development.

This section summarizes information regarding characteristics of the tributary and its adjacent wetlands, if any, and it helps determine whether or not the standards for jurisdiction established under *Rapanos* have been met.

The agencies will assert jurisdiction over non-navigable tributaries of TNWs where the tributaries are “relatively permanent waters” (RPWs), i.e. tributaries that typically flow year-round or have continuous flow at least seasonally (e.g., typically 3 months). A wetland that directly abuts an RPW is also jurisdictional. If the aquatic resource is not a TNW, but has year-round (perennial) flow, skip to Section III.D.2. If the aquatic resource is a wetland directly abutting a tributary with perennial flow, skip to Section III.D.4.

A wetland that is adjacent to but that does not directly abut an RPW requires a significant nexus evaluation. Corps districts and EPA regions will include in the record any available information that documents the existence of a significant nexus between a relatively permanent tributary that is not perennial (and its adjacent wetlands if any) and a traditional navigable water, even though a significant nexus finding is not required as a matter of law.

If the waterbody⁴ is not an RPW, or a wetland directly abutting an RPW, a JD will require additional data to determine if the waterbody has a significant nexus with a TNW. If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. If the JD covers a tributary with adjacent wetlands, complete Section III.B.1 for the tributary, Section III.B.2 for any onsite wetlands, and Section III.B.3 for all wetlands adjacent to that tributary, both onsite and offsite. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
