If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

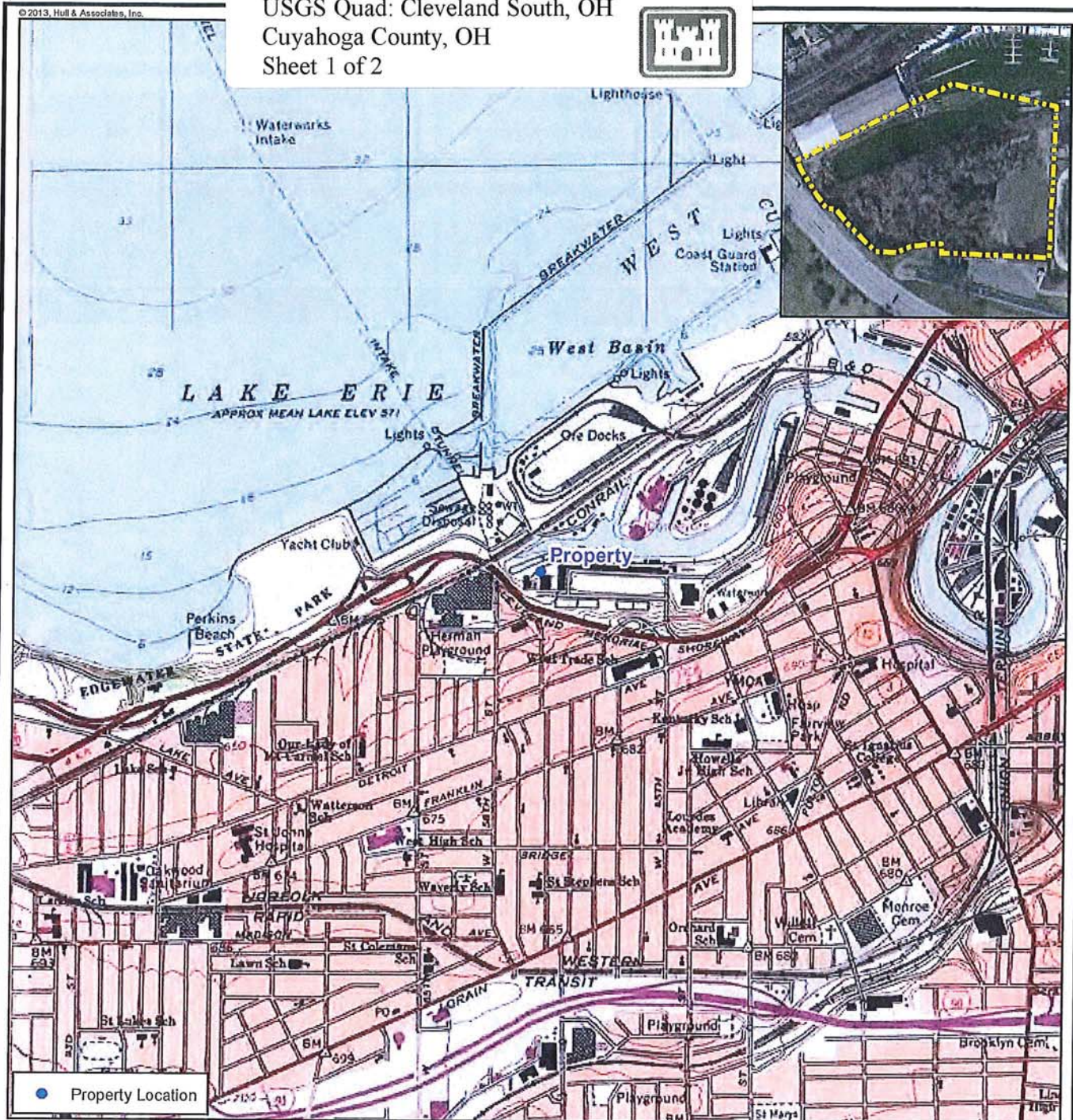

B. ADDITIONAL COMMENTS TO SUPPORT JD: A palustrine open water (POW) feature (0.28 acre) with vegetated fringe was identified on the subject site. However, this feature was determined to be a non-Water of the U.S. as it is a waterfilled depression with a concrete building foundation substrate incidental to construction activity and human induced hydrology. In accordance with 33 CFR 328.3(e) the resource is not federally jurisdictional and not regulated under Section 404 of the Clean Water Act (CWA). LRB does not concur with the USACE Huntington District (LRH) jurisdictional determination dated October 27, 2010 pertaining to this POW feature, which determined the feature (referred to in the LRH October 27, 2010 JD as "Wetland 3") measured 0.02 acre and was a federally jurisdictional water regulated under Section 404 of the CWA. The USACE Buffalo District (LRB) verified that the POW with vegetated fringe mapped on the subject site measures approximately 0.28 acre, and the 0.02 acre measurement specified in the October 27, 2010 LRH JD appears to be a clerical error. Review of in-office resources including numerous aerial photos, USGS OH-Cleveland South quadrangle, NWI OH-Cleveland South map, Cuyahoga County soil survey, as well as geo-technical information, soil sample data, and site photos etc. provided by Hull & Associates, Inc. (Hull) indicate the feature (referred to in the LRH October 27, 2010 JD as "Wetland 3") is a palustrine open water (POW) with a 'substrate' consisting of a man-made building foundation, and possessing a vegetated fringe. Per the regulation at 33 CFR 328.3(e) it is not the intent of Section 404 of the CWA to regulate waterfilled depressions created incidental construction activity. Based on the information provided by Hull, review of in-office resources, and per the regulation at 33 CFR 328.3(e), the USACE LRB has determined that the POW with vegetated fringe on the subject site (referred to by Hull and in the LRH 27-OCT-2010 JD as "Wetland 3") created incidental construction activity is non-federally jurisdictional, not a Water of the U.S., and not subject to regulation under Section 404 of the CWA.

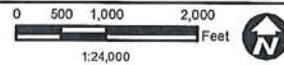

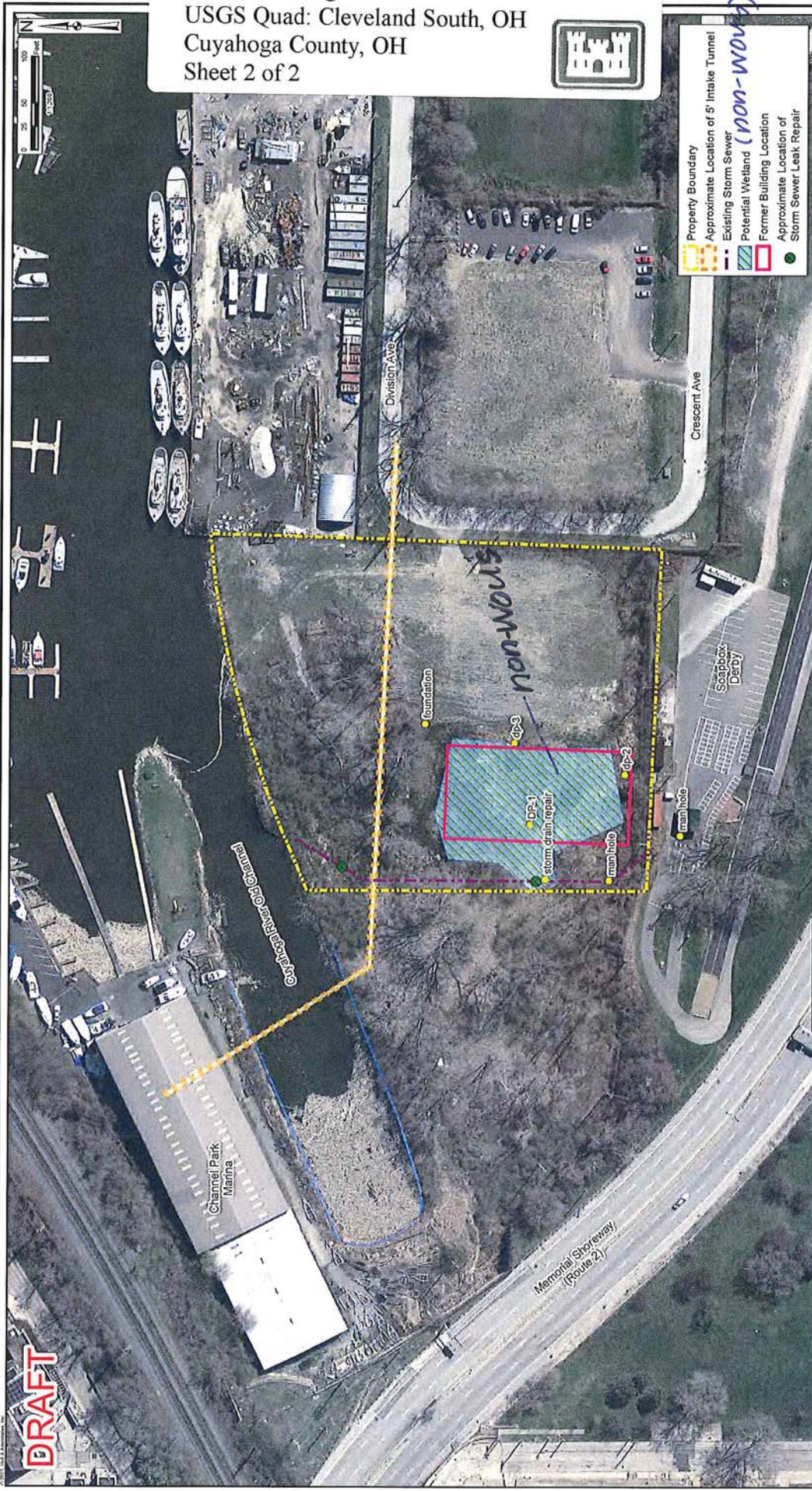
