Surface flow is: Discrete and Confined

Characteristics: During our July 30, 2015, site visit, we observed that the wetland continues beyond the property boundary where the wetland delineation was performed. Less than 20 feet from the edge of the wetland there is a channel approximately 8-10 inches deep and approximately 12 inches wide with an unvegetated bottom and blackened leaves in some areas of the channel. Although no water was flowing at the time of our site visit, the evidence suggests it has flowing water long enough during the growing season to prevent vegetative growth within the channel. This channel can be seen on aerial photography going back at least to 2002 and in most photos appears to be carrying water. There is another channel seen in all the photos appearing to carry water from the same wetland that meets up with the observed channel, with both draining directly into the unnamed tributary. This unnamed tributary is named Ditch 4 on the Town of Amherst Ditch Network map. It appears that at least during rain events and snowmelt, these channels provide a surface water connection between the wetland and Ditch 4, which flows to Ellicott Creek to Tonawanda Creek. Ditch 4 also has a surface water connection through the larger wetland complex of Great Baeher Swamp to Ditch 26B. Ditch 26B flows directly into Ransom Creek which then flows into Tonawanda Creek.

Summarize overall biological, chemical and physical functions being performed: The 0.28-acre wetland in the review area is within 50-100 feet of the Great Baehre Swamp Wildlife Management Area, which consists of 270 acres of various wetland types providing habitat for a variety of species and is a large part of the Ransom Creek watershed (via Amherst Town Ditch 26B) and appears to also provide flow to Ellicott Creek via Amherst Town Ditch \$. The wetland within the review area and the Great Baehre Swamp receive runoff from a largely developed area. In combination, the wetlands function well to moderate downstream flows and likely have the capacity to recharge local groundwater. Other functions include flood attenuation /runoff storage, pollutant trapping/water quality, removal of suspended solids, dissolved solids, toxins and treatment of nitrogen and phosphorus, and valuable wildlife habitat.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

4. The 0.28-acre wetland directly affects the nature of the water entering the unnamed tributary and its downstream receiving waters, both in quantity and chemical/physical attributes. This occurs through the reduction of runoff rates of water received by the unnamed tributary resulting from attenuation and storage of floodwaters; capture of water through evapotranspiration; storage of runoff; and filtering and/or storage of nutrients, chemicals, and sediments contained in rainfall, runoff, or other hydrologic inputs. Ultimately, this affects the downstream TNW, the Erie Canal, as the wetland alters the amount of flow reaching the TNW and furthermore, any additional matter such as nutrients, chemicals, sediments, and pollutants carried in that flow. The Erie Canal Watershed has impairments including increasing urbanization bringing impervious surfaces, increased erosion, sediment which impairs aquatic life and widens flood areas, habitat loss, and loss of wetlands. Since the wetlands and tributary are located in close proximity to residential and commercial developments, major roadways, and agricultural fields and they receive a majority of their hydrology from runoff associated with the adjacent development, roads, and agricultural fields, they provide an important function of reducing the effects of runoff and storm sewer impacts on the downstream TNW. The stream conveys water that has been filtered from the wetlands to the downstream TNW. The wetland also attenuates sediment, nutrients, and pollutants contained in their received water. Combined, the wetland and tributary supply the downstream TNW with a cleaner source of water that will aid in reducing impairments. The presence of these waters also aids with impairments caused by impervious surfaces and construction at headwaters by persisting in their natural state. Due to the physical, biological, and chemical connectivity of the wetland as described above, it has been determined that the wetland has a significant nexus with the downstream TNW, the Erie Canal as the functions and services provided by the stream and its adjacent wetlands provide more than a speculative effect on the physical integrity of the Erie Canal.
