This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Draw connections between the features documented and the effects on the TNW, as identified in the *Rapanos* Guidance and discussed in the Instructional Guidebook. Factors to consider include, for example:

B. ADDITIONAL COMMENTS TO SUPPORT JD: The existing pond with its spillway was originally dug in uplands in the mid 1960's. The artificial pond (1.85 acres) is located at the top of a hill with no potential natural inlets from jurisdictional streams. The pond was created by excavating and diking dry land in order to collect and retain water. It collects surface sheet flow from the surrounding area and discharges overflow water from the pond through the spillway. The water in the pond is used primarily for irrigation and as a swimming pond and thus, (as per Preamble to the 1986 Regulations CFR 33 Section 328.3 (Can be found in Federal Register Vol. 51, No. 219, Page 41217)) the artificial pond is not a WOUS and thus it is non-jurisdictional. The spillway is a man-made swale (approximately 800 linear feet), a shallow drainage feature that was dug in uplands in order to convey possible overflow from the artificial pond. The spillway is lined with grass and other low-lying vegetation throughout the entire length of the swale and thus, (as per US ACE Jurisdictional Determination Form Instructional Guidebook) the spillway was determined to not be a WOUS and is non-jurisdictional.
