- Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional.
Explain: The entire perimeter of Wetland B (0.077-acre) was walked and no outlet was found. Unlike the other wetlands on the site, this is a small depression with a lower elevation that may not allow for overland sheetflow to reach the creek or the other wetlands even during a storm event. The wetland is approximately 200 feet from the creek and no evidence of subsurface flow was observed. Therefore, the wetland is unlikely to have a chemical or hydrological nexus to a downstream TNW. The wetland does not appear to receive or maintain enough surface water of sufficient frequency, duration, or depth to sustain amphibian egg masses or aquatic insect larvae, for example. The

Summarize overall biological, chemical and physical functions being performed: Based on aerial photography, mapped NWI and DEC wetlands, the large wetland complex that contains Wetlands A, C, and D are roughly estimated at 150 to 190 acres. In combination, these wetlands and Wetland E function well to moderate downstream flows and likely have the capacity to recharge local groundwater. Other functions include flood attenuation /runoff storage, pollutant trapping/water quality, removal of suspended solids, dissolved solids, toxins and treatment of nitrogen and phosphorus, and valuable wildlife habitat.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

This occurs through the reduction of runoff rates of water received by Big Sixmile Creek resulting from attenuation and storage of floodwaters; capture of water through evapotranspiration; storage of runoff; and filtering and/or storage of nutrients, chemicals, and sediments contained in rainfall, runoff, or other hydrologic inputs. Ultimately, this affects the downstream TNW, the Niagara River, as the wetland alters the amount of flow reaching the TNW and furthermore, any additional matter such as nutrients, chemicals, sediments, and pollutants carried in that flow. The Niagara River Watershed has impairments including increasing urbanization bringing impervious surfaces, increased erosion, sediment which impairs aquatic life and widens flood areas, habitat loss, and loss of wetlands. Since the wetlands and tributary are located in close proximity to residential and commercial developments, major roadways, and agricultural fields and they receive a majority of their hydrology from runoff associated with the adjacent development, roads, and agricultural fields, they provide an important function of reducing the effects of runoff and storm sewer impacts on the downstream TNW. The stream conveys water that has been filtered from the wetlands to the downstream TNW. The wetland also attenuates sediment, nutrients, and pollutants contained in their received water. Combined, the wetland and tributary supply the downstream TNW with a cleaner source of water that will aid in reducing impairments. The presence of these waters also aids with impairments caused by impervious surfaces and construction at headwaters by persisting in their natural state. Due to the physical, biological, and chemical connectivity of the wetland as described above, it has been determined that the wetland has a significant nexus with the downstream TNW, the Niagara River as the functions and services provided by the stream and its adjacent wetlands provide more than a speculative effect on the physical integrity of the Niagara River.
