- Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional.  
Explain: Wetland B 0.1-acre and Wetland C 0.03-acre, the entire perimeter of each were walked. They are both depressional wetlands created by past earth work on the property, the wetland areas are up against a large fill pile on the east side of them and the elevation around the other sides of the wetlands are approximately 2-3 foot higher than the wetlands. Although Wetland C is close to Wetland A there is a berm between them approximately 20-30 foot wide and approximately 2-3 foot high and no evidence was found that the water from either Wetland C or Wetland B rises high enough to make it over the berm. Due to the small drainage area, it is unlikely that the

wetlands receive sufficient surface water to overcome the distance to the nearest tributary. The factors at 328.3(a)(i-iii) were considered and determined there is no substantial nexus to interstate or foreign commerce.

This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. ### C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Draw connections between the features documented and the effects on the TNW, as identified in the *Rapanos* Guidance and discussed in the Instructional Guidebook. Factors to consider include, for example:

This short tributary makes up the relevant reach. Evidence indicates surface water flows on a regular basis from the wetland to the Erie Canal. Therefore, the wetland has the capacity to carry pollutants, flood water, and nutrients to the TNW.
