Explain: Wetlands A, B, and D were determined to be isolated with no surface or shallow subsurface hydrological connection with a downstream TNW. Additionally, there was no ecological continuum to a downstream TNW as there was no evidence to indicate or support the presence of amphibians or other aquatic habitats sharing a connection between the wetlands and a downstream TNW. Wetlands A & B extend offsite to the west and then south towards Fairmount Boulevard, which serves as the southern limits of the project area. An extensive review of the southwest corner of the parcel did not show any roadside ditches, culverts stormwater receivers, or other

conduits providing a connection to a downstream TNW. Wetland D is located on a slightly south sloping hillside, the runoff of which, lacks any surface water connection to a downstream TNW. These wetlands have no potential to affect interstate commerce under 328.3(a)(3)(i-iii) (See Section IVB of this form); and therefore, are considered to be intrastate, non-navigable, isolated waters.

If the waterbody⁴ is not an RPW, or a wetland directly abutting an RPW, a JD will require additional data to determine if the waterbody has a significant nexus with a TNW. If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Draw connections between the features documented and the effects on the TNW, as identified in the *Rapanos* Guidance and discussed in the Instructional Guidebook. Factors to consider include, for example:

- Does the tributary, in combination with its adjacent wetlands (if any), have the capacity to carry pollutants or flood waters to TNWs, or to reduce the amount of pollutants or flood waters reaching a TNW?

- Does the tributary, in combination with its adjacent wetlands (if any), have other relationships to the physical, chemical, or biological integrity of the TNW?
