2. is not an interstate water/wetland; **neither ditch crosses state boundaries**

Ditch A, measures 0.04 acres and is located between two drainage culverts. The only source of input to the ditch is from roadway runoff and surface rainwater runoff. One of the culverts is improperly sited which causes up to 6 inches of standing water in the ditch and does not allow for runoff to travel properly through the ditch. There is no flow from this standing water and the only way water has to leave the ditch is through evaporation. The soils in the area are all indicated as upland soils, demonstrating that the ditch was excavated from upland soils. The ditch does not connect WOUS, at the input of the first culvert there are obvious swales that show the only water input is from rainwater and roadway runoff. Ditch C measures 0.15 acres and serves as a rainwater and roadway runoff drainage system. The soils in the area show that Ditch C was also excavated from upland soils, there is no sign of relatively permanent flow, and the major input is from rainwater and roadway runoff with no connection to WOUS.

Corps districts and EPA regions will include in the record any available information that documents the existence of a significant nexus between a relatively permanent tributary that is not perennial (and its adjacent wetlands if any) and a traditional navigable water, even though a significant nexus finding is not required as a matter of law.

If the waterbody<sup>4</sup> is not an RPW, or a wetland directly abutting an RPW, a JD will require additional data to determine if the waterbody has a significant nexus with a TNW. If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. ### C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Draw connections between the features documented and the effects on the TNW, as identified in the *Rapanos* Guidance and discussed in the Instructional Guidebook. Factors to consider include, for example:

- Other: (explain, if not covered above): Ditch A and C cannot be used by interstate or foreign travelers for recreational or other purposes, fish or shellfish cannot be taken and sold in interstate or foreign commerce, and the ditches could not be used for industrial purposes by interstate commerce. Ditch A, measures 0.04 acres and is located between two drainage culverts. The only source of input to the ditch is from roadway runoff and surface rainwater runoff. One of the culverts is improperly sited which causes up to 6 inches of standing water in the ditch and does not allow for runoff to travel properly through the ditch. There is no flow from this standing water and the only way water has to leave the ditch is through evaporation. The soils in the area are all indicated as upland soils, demonstrating that the ditch was excavated from upland soils. The ditch does not connect WOUS, at the input of the first culvert there are obvious swales that show the only water input is from rainwater and roadway runoff. Ditch C measures 0.15 acres and serves as a rainwater and roadway runoff drainage system. The soils in the area show that Ditch C was also excavated from upland soils, there is no sign of relatively permanent flow, and the major input is from rainwater and roadway runoff with no connection to WOUS.

- or  Other (Name & Date): onsite photos from October 2016 within delineation packet show that the inlet for both Ditch A and C are from erosional features and swales, that Ditch A holds standing water due to the improperly sited culvert, and that Ditch C does not have a high water mark and shows no other signs of being jurisdictional.

Both Ditch A and Ditch C are fed from rainwater and roadway runoff from the eastern side of the site through a number of swales. There is no evidence that the ditches connect two WOUS.
