- Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional.  
Explain: Site visit was conducted on October 26, 2016 at the 22-acre Giusiana Architects & Engineers site, located along the east side of Washington Drive in the Town of Lewiston, County of Niagara, New York. In addition, a review of in-house resources including, topographical maps, aerial photography and soils maps were looked at. The boundary of Wetland 1 (0.28 acres) and Wetland 2 (0.59 acres) were walked. No surface flows or culverts were observed going away from the wetlands. No storm-drains were found near the wetlands. No drainage patterns or mapped draineways were found on aerial imagery or the USGS Lewiston quad map in close proximity to

## Wetlands 1 and 2.

Wetlands 1 (0.28 acres, PSS) and 2 (0.59 acres PSS/PFO) boundaries were walked and based on the on-site walkover and review of in-house resources it was determined the wetlands are closed depressional wetlands that were not abutting or adjacent to drainage-ways nor appeared to flow directly into a drainage-ways or a TNW. A review of aerial imagery indicated Wetlands 1 and 2 to be more than 200-350 feet away from a drainageway that leads to a stormwater outfall to the south, adjacent to Wetland 4. Wetlands 1 and 2 are more than 750-900 feet away from a drainageway (offsite) that runs along the back of the parcel to the east. Wetlands 1 and 2 to be more than 8,600 feet away from the Niagara River (Section 10 Waterway) to the west. During the site visit, Wetland 1 was observed to be a deep pocket wetland that could have been a burrow area to provide fill for the surrounding development.

No ecological nexus between the wetlands were seen in the vicinity of the wetlands. During the site visit, hydrology was not present within the wetlands. There was no evidence of drainage or flow from the wetlands to drainageways, roadside ditches nor appeared to flow directly into ditches or a TNW. Due to the lack of drainageways around the wetland and on-site soil conditions, it is unlikely that any shallow subsurface connection exists between the wetlands. Wetlands 1 and 2 are physically and geographically isolated in a depression on the landscape and water would not make it to a TNW. The remaining wetlands, Wetlands 3, 4, 5 and Stream 1 will be verified under a Preliminary Jurisdictional Determination.

**C. SIGNIFICANT NEXUS DETERMINATION**

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations

when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

**B. ADDITIONAL COMMENTS TO SUPPORT JD:** Isolated wetlands 1 (0.28 acres) and 2 (0.59 acres) were field verified by the Corps of Engineers on October 26, 2016. The perimeters of wetland 1 and 2 were walked and no evidence of any connections to other waters were identified. There were no connections between the wetlands and any other waters on the Lewiston Quad, the USDA/NRCS Web Soil Survey or aerial imagery. The Wetlands are isolated and outside the Department of the Army's jurisdiction. The determination is supported by the review of in-house resources and field verified. None of the 328.3(a)(3)(i-iii) factors are relevant in this case. The wetlands don't support recreational or other use by interstate travelers, nor provide habitat for amphibians or other aquatic species. The wetlands offer no use for industrial or commercial purposes. The wetlands were determined to be isolated and therefore non-jurisdictional. The remaining wetlands, Wetland 3, 4 and 5, will be verified under a Preliminary Jurisdictional Determination.
