C. **SIGNIFICANT NEXUS DETERMINATION**

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent

wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: Explain rationale for determination that the review area only includes dry land:

A site visit was conducted on April 28, 2017 to determine if any wetland areas were present on the approximate 2.28-acre parcel. The parcel sits between the steep grades of a former rail bed and County Road 4 adjacent to Flint Creek. At first glance, it would appear that the parcel would support wetland characteristics, however, no wetlands were observed and the site was found to present predominately upland characteristics. Formal data sheets were not completed by the Corps, but general observations are as follows:

The parcel is adjacent to Flint Creek, a perennial stream that flows through several counties and outfalls to the Erie Canal in Lyons, New York. Although the Creek flows through the property, a JD was not requested for this stream.

Vegetation: FACU = Facultative Upland; FAC = Facultative; FACW = Facultative Wetland; OBL = Obligate

The following species were observed: tartarian honeysuckle (*Lonicera tatarica* - FACU), European buckthorn (*Rhamnus cathartica* - FAC), black cherry (*Prunus serotina* - FACU), silver maple (*Acer saccharinum* - FACW), black walnut (*Juglans nigra* - FACU) and a few American sycamore (*Platanus occidentalis* - FACW) were observed throughout the parcel; with honeysuckle as the dominant understory species. Patches of skunk cabbage (*Symplocarpus foetidus* - OBL) were observed, occurring along the overland sheet flow pathway from road runoff down a steep roadway grade. Presence of silver maple and sycamore was not surprising given that the parcel is adjacent to Flint Creek, which overtops its banks during storm events. Further, since the parcel is relatively flat, the water table is likely within the root zone of canopy trees.

Evidence of Hydrology: No rack lines, water stained leaves, water lines on trees/vegetation, or standing water was observed.

Soil: Four shovel pits were excavated to determine soil hue, value/chroma, and are labeled as Data Point (DP) 1, 2, 3, and 4
