2. Characteristics of wetlands adjacent to non-TNW that flow directly or indirectly into TNW

(i) **Physical Characteristics:**

(a) General Wetland Characteristics:

Properties:

Wetland size: Wetland A (1.33 ac), Wetland B (0.81 ac), Wetland C (0.23 ac), Wetland D (0.78 ac). 3.15 total acres.

Wetland type. Wetland B – Palustrine emergent, Wetlands A, C, and D – Palustrine forested. Explain: Wetland types listed are based on reviews of multiple aerial photos taken prior to wetlands being cleared and graded in the summer of 2017. Site has been disked and planted with cover crop.

Wetland quality. Explain: Overall - Moderate. The 7.5 acre parcel is surrounded by residential and commercial development. Prior to disturbance, Wetland B - typified by Phragmites and Wetlands A, C, and D were forested with occasional saturation or inundation.

Project wetlands cross or serve as state boundaries. Explain:

(b) General Flow Relationship with Non-TNW:

Flow is: **Ephemeral flow**. Explain: During spring snow melt or periods of extended precipitation, the shallow, concave surfaces typifying the wetland landscape are hydrologically connected by discrete and confined surface flows, which, while modified, typically drains north across the site..

Surface flow is: **Discrete and confined**

Characteristics: See 2.b above .

Subsurface flow: **Yes**. Explain findings: Drainage across the site has been modified, 4 stormwater receivers were constructed along the north edge of the site after it was cleared and drainage swales have been constructed across the site to improve drainage to the receivers. The receivers are part of a subsurface stormwater conveyance system that drains north and west following Worden Road to Fairway Blvd., to E 293rd St. to Lakeshore Blvd. The stormwater system daylights at an outfall located at Larimar Lakefront Neighborhood between Seaview Rd. and Larimar St. Water from the outfall flows approximately 600 feet northwest through and open channel to Lake Erie. Observations made by the city engineer indicate the flow regime at the outfall is an RPW.

Dye (or other) test performed: The hydrologic connection described above was provided by the City of Willowick Engineer (accompanied by the storm trunk sewer drainage area map for the City).

Explain: Aerial photos from 2011 and 2014 show inundation in much of the forested wetlands A & B. During the Oct. 2016 site visit, areas of Wetlands B & C were saturated to the surface; however no film or sheen was observed. The wetlands on site are in a position to receive urbanized runoff from upland areas to the south (Euclid Ave.). Silt fence is in place to prevent sediment and runoff from the development on the eastern portion of the parcel from reaching the wetlands.

Identify specific pollutants, if known: Unknown.

(iii) **Biological Characteristics. Wetland supports (check all that apply):**

Vegetation type/percent cover. Explain: Prior to clearing and grading, 74% (2.31 ac.) of wetlands identified supported forest vegetation and the remaining 26% (0.81 ac.) supported herbaceous vegetation. Following the disturbance, most wetlands exhibit some degree of sparsely vegetated concave surface.

Habitat for:

Summarize overall biological, chemical and physical functions being performed: Wetlands A, B, C, and D, play an important function in stabilizing and retaining sediment as well as filtering/processing pollutants to benefit downstream surface water quality, thus reducing the amount of pollutants transported to Lake Erie. These wetlands also provide potential habitat for common amphibian, bird, mammalian, and insect species.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Draw connections between the features documented and the effects on the TNW, as identified in the *Rapanos* Guidance and discussed in the Instructional Guidebook. Factors to consider include, for example:

Based on the verified hydrological connection to Lake Erie (a TNW), the ecological services being performed, and the extensive development within the rest of the Lake Erie, lower Euclid Creek, and lower Chagrin River watersheds, Wetlands A, B, C, and D have a significant effect on the physical, chemical, and biological integrity of downstream waters, including Lake Erie. The regulation of these areas and those similar to it is vital to the goals and purpose of the Clean Water Act (CWA).

B. ADDITIONAL COMMENTS TO SUPPORT JD:

The boundaries of the wetlands within the project area are based on wetland delineations performed by HzW Environmental Consultants, LLC on Nov. 1, 2016 and July 25, 2017, additional wetland boundary detail based on data collected by the U.S. Army Corps of Engineers on October 18, 2016, June 28, 2017, a review of aerial photographs, and Digital Elevation Models.

Undisturbed reference conditions were also reviewed on adjacent parcels south and west of the site. No wetland data was collected due to access constraints; however, observations including water stained leaves, saturated/inundated soil conditions, and abundant wetland vegetation indicated that forested wetland conditions likely exist. A review of the 2011 and 2014 Lake County GIS parcel viewer aerial photos indicate both the reference sites and the subject study area have the same saturated/inundated forested wetland appearance.
