A wetland delineation was conducted on the 9.97 acre project review area. Two emergent wetlands, Wetlands 01 (0.14 acres) and 02 (0.5 acres) were identified as isolated wetlands. The wetlands are outside Department of the Army jurisdiction and do not meet the criteria for a jurisdictional water of the United States according to 33 CFR Part 328.3(a)(1-7) as follows:

Both wetlands were walked during the USACE site inspection and were found to be isolated depressions, with no surface water outlets. In addition, no signs of shallow subsurface flows were found. Wetland 02 is 170 linear feet from a TNW (Erie Canal) at its closest location. It is completely confined within the project site and does not extend off-site. The wetland is a mowed field and stops before reaching the shrubs or forested area. The wetland appears to have formed as a result of construction of the school field, is not a naturalized system and does not provide for an ecological connection to the nearby Erie Canal. While a very small portion of Wetland 02 is located over the historic Erie Canal location, under Answer No. 11 of the Regulatory Guidance Letter 16-01 Q&As, it reinforces that "historic" Section 10 aquatic resources that are now "fast land"/dry land and are not considered jurisdictional under Section 404.

If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

The Old Erie Canal appears through the site, but it is unclear if it is a water or shadow from a hedgerow. The 2003, 2008 and 2013 aerial photos are similar. In the 2013 aerial, the area where wetland is mapped appears more abandoned and no longer mowed. Various years from Google Earth Pro were also examined, indicating similar conditions. The streetside view was reviewed, confirming that the Old Erie Canal is filled along the portion next to S. James Street.

He noted: consistent with what we discussed onsite, the area within the power line right of way is the footprint of the original Erie Canal which is confirmed by the ECMP website.
 - . The stretch of old canal onsite is part of the original Erie Canal "Clinton's Ditch" which began active operation in 1825.
 - . Starting in 1832 and ending in 1862 an expansion of the Canal, "the First Canal Expansion" was undertaken.

- . The Expansion provided a new route to the east replacing the section of the Original Canal on the project site.
- . The information noted that little remained of Clinton's Ditch after the Expansion was completed, but did not provide specifics of filling dates, etc.

Based on the information provided:

- . The portion of the old canal on the DePaul Site was decommissioned as a navigable waterway by 1862.
- . The attached historical summary information eludes to the old canal likely being filled upon decommissioning associated with the 1862 Expansion, predating the R&HAA of 1899.

However, the 1955 topo map notes the canal as a blue line stream, so the filling must have occurred after this time.

Site inspection performed by USACE on 8/30/17. At this time, boundaries were confirmed. In addition, it was confirmed that Wetlands 01 and 02 are isolated depressions with no outlets. It was also confirmed that the old Erie Canal no longer exists as a water on or adjacent to the site. This area is now an aerial transmission right-of-way.

Phone conversation between Maggie Crawford and Joe Guiliano of the City of Rome Engineering Department. Mr. Guiliano confirmed that the Clinton's Ditch had been previously filled (and not culverted) at this location.
