Onsite observations indicate this feature was constructed in uplands. There are no adjacent wetlands and no stream channels were observed flowing in/out of the pond. The Aurora OH, USGS 7.5 min quad and Portage County Soil Survey were inspected for evidence of an historic stream channel in the location of the pond. No stream channels were identified in the location of the pond. Thus, based on the above, it was determined that the onsite feature is an excluded b(8) artificial pond.
