Wetlands A and B	1.15 and 0.04	acre(s)	(b)(1) Non-adjacent wetland.	Observations indicate that these wetlands are non-adjacent b(1) waters. These wetlands do not meet any of the four criteria that would make an (a)(4) adjacent water subject to jurisdiction under Section 404 of the Clean Water Act. These wetlands were circumnavigated during the Corps' site visit on October 6, 2020. No defined channels/tributaries/ditches were observed flowing from these wetlands to any (a)(1-3) water. Based on site observations the nearest a(1-3) waters would not flood any of the wetland areas at least once during a typical year. Also, there are no natural berms or the like located between the a(2) onsite waters and these wetlands. Based on the above it has been determined that these wetlands are b(1) excluded waters.
