This wetland does not meet any of the four criteria that would make an (a)(4) adjacent water subject to jurisdiction under Section 404 of the Clean Water Act. This wetland was circumnavigated during the Corps' site visit on October 8, 2020. No defined channels/tributaries/ditches were observed flowing from these wetlands to any (a)(1-3) water. Based on site observations the nearest a(1-3) waters would not flood any of the wetland areas at least once during a typical year. Also, there are no natural berms or the like located between any a(2) water and this wetland. Based on the above it has been determined that this wetland is a b(1) excluded waters.
