C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

According to the technical report, the fish hatchery began operations in the 1930s and consisted of 11 man-made ponds. Throughout the 1970s a majority of the ponds were filled in and use of the remaining ponds ended around 2010. Pond#4 (Wetland#4) has a concrete outlet structure with a 4” PVC outlet pipe with the outlet invert approximately 3 feet higher than the lowest point of the pond. In addition, the delineator stated no hydrology i.e. standing water, saturated soils or primary hydrology indicators were present during the field investigation on September 22, 2021. The absence of primary hydrologic indicators suggests that standing water of sufficient depth to flow through the outlet appears unlikely. The delineator documented bryophytes and organic debris have accumulated in the inboard (pond) side of the outlet structure indicated no flows have occurred through the structure in some time. In addition, the delineator documented accumulated organic debris on the outboard side of the outlet and the presence of lichens on rocks immediately below the outlet indicating no flows from the pond to a small swale 60-75 feet away. From the photos provided, the swale has no defined bed and banks and is heavily vegetated. Finally, the delineator stated no hydrology i.e. standing water, saturated soils or primary hydrology indicators were present during the field investigation on September 22, 2021.

Pond#4 was a constructed, man made pond with a berm surrounding the edges and an engineered outlet structure that has converted to an emergent wetland over time. A review of the data sheets and NRCS Web Soil survey indicates the soils associated with Wetland#4 to be potentially hydric. According to the technical report the higher points of the wetland going up the berms is predominately FACU and UPL vegetation. A review of past aerial imagery and other in-house resources show no drainage patterns coming or going from Wetland #4. No mapped streams, creeks etc. were identified adjacent to or abutting on aerial imagery, USGS Quad map, USFWS Wetland Mapper or the NYSDEC Environmental Resource Mapper.

After reviewing the technical report and in-house resources, there was no evidence of drainage or flow from Wetland#4 to any of the drainage features identified on or adjacent to the delineated parcel. Due to the nature of Wetland#4 and surrounding berm especially with the mapped underlying clay soils, it is unlikely that any shallow subsurface connection exists between the wetland and the nearest drainageways. Wetland#4 is physically and geographically isolated within the surrounding landscape and water would not make it to a TNW (St. Lawrence River)
