This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Wetlands:

Wetlands 002, 003, 004, and 005 are geographically isolated, small depressions within an historic agricultural field that is relatively flat with slight topographic undulations. On-site observations made by the consultant during the October 2020 delineation and the USACE site visit on September 30, 2021 confirm that the wetlands are isolated and have no connection to downstream waters. The nearest RPW is Moorman Creek and the Google Earth measuring tool estimates that the subject wetlands are approximately 1,350 feet from the Creek. Therefore, we have determined that the subject wetlands do not meet adjacency criteria. Further, due to topography and distance to the nearest tributary, the presence of a shallow subsurface flow connection for the wetlands is very unlikely.

Based on the on-site visits, review of aerial photographs, in-house resources and information contained in the delineation report, it has been determined that Wetlands 002, 003, 004, and 005 are outside Department of the Army jurisdiction as they are isolated, intrastate wetlands which have no interstate or foreign commerce nexus.

Swales:

All swales established within an historically active agricultural field. USACE site visit on September 30, 2021 confirmed that these features are all discrete drainages in upland soils that do not have any connectivity to downstream waters. According to the Web Soil Survey:

Swale D001 occurs in Niagara silt loam with a hydric rating of 4 and Galen very fine sandy loam, 2 to 6 percent slopes with a hydric rating of 0.

Swale D002 occurs in Niagara silt loam with a hydric rating of 4, Elnora loamy fine sand, 2 to 6 percent slopes with a hydric rating of 0, and Claverack loamy fine sand, 2 to 6 percent slopes with hydric rating of 0.

Swale D003 occurs in Niagara silt loam with a hydric rating of 4 and Collamer silt loam, 0 to 2 percent slopes with a hydric rating of 0.

Swale D004 occurs in Collamer silt loam, 0 to 2 percent slopes with a hydric rating of 0.

Ditches:

Ditches D005 and D006 (same roadside ditch; but identified as separate features for ease of delineation): It was determined that the roadside ditch does not function as an RPW but functions only to convey stormwater along the

roadside after storm events. The ditch was not constructed in a wetland and does not act as a conveyance of wetland hydrology to downstream waters. According to the Web Soil Survey, the ditch occurs in soils identified as Niagara silt loam with a hydric rating of 4 and Collamer silt loam, 0 to 2 percent slopes with a hydric rating of 0.
