This section summarizes information regarding characteristics of the tributary and its adjacent wetlands, if any, and it helps determine whether or not the standards for jurisdiction established under *Rapanos* have been met.

If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. road culvert. The wetland on the north side of the road flows into the roadside ditch (non-RPW) that flows to the west approximately 2000 feet before entering an unnamed tributary to Pond Brook that flows north, then west (crossing Schultz Road and Hilltop Drive) before entering Pond Brook; a distance of approximately 4300 feet. Pond Brook flows to the north approximately 1.7 miles before entering Buffalo Creek. Buffalo Creek flows to the northeast for approximately 9.2 miles where it meets the confluence of the Buffalo River, a Traditional Navigable Waterway.

Discrete wetland hydrologic connection. Explain: The wetland abuts the roadside ditch (non-RPW) and has a confined flow pattern into the roadside ditch which crosses through a roadside culvert into a roadside ditch that has ephemeral flow to the east into an intermittent RPW (an unnamed tributary to Pond Brook).

Separated by berm/barrier. Explain: The wetland on the subject parcel is located on the south side of Rice Road where it abuts a roadside ditch that continues on the north side. Also on the north side of Rice Road, the roadside ditch extends to the west where it turns north and becomes a naturalized (man-manipulated) stream channel.

Summarize overall biological, chemical and physical functions being performed: This wetland is a headwater wetland serving as the primary collector of organic matter before being transported and conveyed to downstream waters. This wetland provides stormwater retention, nutrient sorting and retention, watershed connectivity, pollutant filtration, biological productivity of micro/macro flora and fauna, decomposition, and community structure; and wildlife support including providing habitat and foodchain connectivity.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

RELEVANT REACH

The wetland abuts a roadside ditch located just outside the study area (to the north of the wetland), which carries water to a under-road culvert to the east, located beneath Rice Road. The culvert connects flow to a roadside ditch (Non-RPW) on the north-side of Rice Road that is part of a functioning wetland to the north of Rice Road; roadside ditch constructed within a wetland. The non-RPW (roadside ditch on the north side of Rice Road) flows to the west along Rice Road in a relatively straight manor where it connects to a man-altered stream, an unnamed tributary to Pond Brook (intermittent flowing RPW). During the July 12, 2021 site visit water was present in the wetland and roadside ditch (non-RPW), but flow was not occurring at this particular time of the year (Dry season), though was evident due to the destruction of vegetation and flow patterns through the vegetation. This indicated that the flow from Wetland 1 is ephemeral into the non-RPW leading into the seasonal RPW as described earlier on this form.

SIGNIFICANT FACTORS

Wetland 1 is a hardwood swamp containing high diversity of wetland vegetation with few invasive species, offering a variety of chemical processes to filter out pollutants from the surrounding area that is experiencing new residential development and also has agriculture runoff presence within the watershed. Wetland 1 abutting the non-RPW (roadside ditch constructed in wetlands) allows for slow filtration (removing nutrients and pollutants) of the stormwater that collects within Wetland 1, contributing cleaner water downstream to the western-located seasonal RPW, an unnamed tributary to Pond Brook. Water quality of receiving waters is strongly influenced by the quality of water coming from this headwater wetland. Further, the storage and transformation of organic matter from headwaters to the receiving waters is important to prevent degradation of water quality within the watershed. Wildlife habitat functions of Wetland 1 are considered moderate to high due to the limited number of wetlands that remain in the area.

CONCLUSION

Wetland 1 directly abuts the non-RPW and provides ephemeral flow from the wetland into the non-RPW. Both Wetland 1 and the non-RPW were found to influence the chemical, physical, and biological integrity of downstream waters. Based on the information on this form, it has been determined that a significant nexus exists between Wetland 1 through the off-site non-RPW, and the Seasonal RPW to the Buffalo River and Lake Erie, navigable waterways of the United States. Therefore, it has been determined that Wetland 1 is a jurisdictional water of the United States.
