C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Wetland C is approximately 1000 linear feet (straight) from the nearest tributary; which is Tributary B on-site to the northwest, as documented on the PJD, dated January 27, 2021. Wetland E is approximately 1500 linear feet (straight) from the nearest tributary, which is Tributary B on-site to the northwest. Wetland F is approximately 1700 linear feet (straight) from the nearest tributary, which is Tributary B on-site to the northwest. Wetland D is approximately 120 linear feet (straight) to the east of Tributary B, the nearest tributary. For each of these wetlands, it was determined that no clear surface water connection exists between the wetlands and a water of the United States. Further, due to topography and distance to the nearest tributary of each wetland, the presence of a shallow subsurface flow connection is very unlikely. Specific to Wetland D, Tributary B is relatively close, but the topography of the area rose slightly to the west towards the tributary and there was old fill along Tributary B that would block any surface water entering Tributary B. Each wetland is isolated, completely surrounded by uplands as reported in the delineation report submitted by BME Associates, dated August 2021 and as verified during a Corps of Engineers' site visit of the review area on September 30, 2021. These wetlands are depressional in a review area with relatively flat topography across the entire site. For the above reasons, these wetlands are isolated, intrastate, non-navigable waters with no potential to affect interstate commerce under 328.3(a)(3)(i-iii). (See Section IV B) and therefore, not subject to jurisdiction.
