C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

A site visit was conducted at the subject parcel on December 10, 2021. In addition, a wetland delineation report (dated May 13, 2021) submitted by Earth Dimensions, Inc was reviewed. Finally, in-house resources including, topographical maps, aerial photography and soils maps were reviewed. After review of the available resources, delineation report, and observations from the field, no surface water flows or culverts were located flowing from Wetland 1 (0.425 acres).

The boundary of Wetland 1 was walked and based on the on-site walkover and review of in-house resources it was determined the wetland is a closed depressional wetland that was not abutting or adjacent to a drainage-way nor appeared to flow directly into a drainage-way or a TNW. No waterway, stormwater system, culverts, rear yard drains or roadside drainage were found on or adjacent to the delineated parcel. The linear portion of the wetland was determined not to be a waterway as no bed or banks were found and the feature is just a “finger” extension of Wetland 1. In addition, a desk top review of available resources showed no onsite or offsite drainageways, roadside ditches, stormwater systems etc. The wetland is situated within an urban landscape surrounded by residential and commercial development on all sides and at different elevations. Over the years, disturbances from the surrounding developments and disposal of upland fills i.e. vegetative debris, appears to have led to the formation of the shape and size of Wetland 1. The wetland is a shallow surface concave depression that collects water and holds it long enough to provide wetland characteristics but do not drain from any surface connections and any subsurface connection would be speculative but based on the topography would not be expected to occur.

After performing a site visit, reviewing the delineation report and in-house resources there was no evidence of drainage or flow from the wetland to any drainage within the vicinity. The wetland is physically and geographically isolated within a depression on the landscape and water would not make it to a TNW. An ecological nexus between the wetland and any surrounding wetlands or waterways is nonexistent because no wetlands or drainageways are within the vicinity of the wetland. The wetland is isolated, intrastate wetland which has no interstate or foreign commerce nexus.
