### C. SIGNIFICANT NEXUS DETERMINATION

**A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.**

**Wetland A (0.15-acre)** – is located in the extreme northeast corner of the site. Wetland A appeared to extend off-site to the east. Since the property to the east could not be accessed, a review of ConnectExplorer aerial imagery was done for dates 11/24/2021, 3/13/2021, 11/12/2020, 4/14/2020, 4/9/2019, 4/7/2018, 4/8/2017 and did not reveal evidence that there is a direct hydrologic surface connection to Carpenter Ditch or the Unnamed Tributary to Carpenter Ditch, both of which are approximately 0.35-miles away from the wetland. Based upon site visit observations and a review of aerial imagery, it has been determined that Wetland A is an isolated wetland which is not adjacent to or directly abutting a RPW or NRPW and cannot be used by interstate or foreign travelers for recreational or other purposes; or from which fish or shellfish are or could be taken and sold in interstate or foreign commerce; or which are used or could be used for industrial purposes by industries in interstate commerce.

**Wetland B (0.55-acre)** – is located along the eastern boundary of the site. Wetland B appeared to extend off-site to the east. Since the property to the east could not be accessed, a review of ConnectExplorer aerial imagery was done for dates 11/24/2021, 3/13/2021, 11/12/2020, 4/14/2020, 4/9/2019, 4/7/2018, 4/8/2017 and did not reveal evidence that there is a direct hydrologic surface connection to Carpenter Ditch or the Unnamed Tributary Carpenter Ditch, both of which are approximately 0.35-miles away from the wetland. Based upon site visit observations and a review of aerial imagery, it has been determined that Wetland B is an isolated wetland which is not adjacent to or directly abutting a RPW or NRPW and cannot be used by interstate or foreign travelers for recreational or other purposes; or from which fish or shellfish are or could be taken and sold in interstate or foreign commerce; or which are used or could be used for industrial purposes by industries in interstate commerce.

**Wetland C (0.05-acre)** – is located entirely within the site. The entire perimeter of the wetland was walked and a direct hydrological surface connection to Carpenter Ditch or the UTCD was not observed. In addition, a review of ConnectExplorer aerial imagery was done for dates 11/24/2021, 3/13/2021, 11/12/2020, 4/14/2020, 4/9/2019, 4/7/2018, 4/8/2017 and did not reveal evidence that there is a direct hydrologic surface connection to Carpenter Ditch or the Unnamed Tributary Carpenter Ditch, both of which are approximately 0.35-miles away from the wetland. Based upon site visit observations and a review of aerial imagery, it has been determined that Wetland C is an isolated wetland which is not adjacent to or directly abutting a RPW or NRPW and cannot be used by interstate or foreign travelers for recreational or other purposes; or from which fish or shellfish are or could be taken and sold in interstate or foreign commerce; or which are used or could be used for industrial purposes by industries in interstate commerce.

**Wetland D (0.11-acre)** – Wetland D is located on the extreme southeast corner of the site. Wetland D appeared to extend off-site to the south. Since the property to the south could not be accessed, a review of ConnectExplorer aerial imagery was done for dates 11/24/2021, 3/13/2021, 11/12/2020, 4/14/2020, 4/9/2019, 4/7/2018, 4/8/2017 and did not reveal evidence that there is a direct hydrologic surface connection to Carpenter Ditch or the Unnamed Tributary Carpenter Ditch, both of which are approximately 0.35-miles away from the wetland. Based upon site visit observations and a review of aerial imagery, it has been determined that Wetland D is an isolated wetland which is not adjacent to or directly abutting a RPW or NRPW and cannot be used by interstate or foreign travelers for recreational or other purposes; or from which fish or shellfish are or could be taken and sold in interstate or foreign commerce; or which are used or could be used for industrial purposes by industries in interstate commerce.

**Wetland E (0.01-acre)** – is located entirely within the site. The entire perimeter of the wetland was walked and a direct hydrological surface connection to Carpenter Ditch or the UTCD was not observed. In addition, a review of ConnectExplorer aerial imagery was done for dates 11/24/2021, 3/13/2021, 11/12/2020, 4/14/2020, 4/9/2019, 4/7/2018, 4/8/2017 and did not reveal evidence that there is a direct hydrologic surface connection to Carpenter Ditch or the Unnamed Tributary Carpenter Ditch. Based upon site visit observations and a review of aerial imagery, it has been determined that Wetland E is an isolated wetland which cannot be used by interstate or foreign travelers for recreational or other purposes; or from which fish or shellfish are or could be taken and sold in interstate or foreign commerce; or which are used or could be used for industrial purposes by industries in interstate commerce.

**Wetland F (0.09-acre)** – is located entirely within the site. The entire perimeter of the wetland was walked and a direct hydrological surface connection to Carpenter Ditch or the UTCD was not observed. Wetland G (0.05-acre) is connected to Wetland J and both wetlands extend off-site to the west, according to a 4/10/2006 Connect Explore aerial image. Since the property to the west could not be accessed, a review of ConnectExplorer aerial imagery was done for dates 11/24/2021, 3/13/2021, 11/12/2020, 4/14/2020, 4/9/2019, 4/7/2018, 4/8/2017 did not reveal evidence that there is a direct hydrologic surface connection to Carpenter Ditch or the Unnamed Tributary Carpenter Ditch, both of which are approximately 0.35-miles away from the wetland. Wetland H (0.72-acre) – is located on the extreme western boundary of the site. Since the property to the west could not be accessed, a review of ConnectExplorer aerial imagery was done for dates 11/24/2021, 3/13/2021, 11/12/2020, 4/14/2020, 4/9/2019, 4/7/2018, 4/8/2017 did not reveal evidence that there is a direct hydrologic surface connection to Carpenter Ditch or the Unnamed Tributary Carpenter Ditch, both of which are approximately 0.35-miles away from the wetland. Since the property to the west could not be accessed, a review of ConnectExplorer aerial imagery was done for dates 11/24/2021, 3/13/2021, 11/12/2020, 4/14/2020, 4/9/2019, 4/7/2018, 4/8/2017 did not reveal evidence that there is a direct hydrologic surface connection to Carpenter Ditch or the Unnamed Tributary Carpenter Ditch, both of which are approximately 0.35-miles away from the wetland.
