### C. SIGNIFICANT NEXUS DETERMINATION

**A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.**

**Wetland E (0.26-acre) – is located in the extreme western portion of the site. Wetland E is located entirely on-site. During the on-site field visit conducted on 8-OCT-2020, the entire perimeter of the wetland was walked and was observed to be surrounded by upland and a direct hydrological connection was not observed from this wetland to a Relatively Permanent Water (RPW) or a Non-relatively Permanent Water (NRPW). Wetland E is 734 linear feet from the nearest RPW, which is Stream 2A that was identified in the LRH-2014-00051 preliminary jurisdictional determination. Based upon site visit observation, it has been determined that Wetland E is an isolated wetland which is not adjacent to or directly abutting a RPW or NRPW and cannot be used by interstate or foreign travelers for recreational or other purposes; or from which fish or shellfish are or could be taken and sold in interstate or foreign commerce; or which are used or could be used for industrial purposes by industries in interstate commerce.**

**Wetland F (0.08-acre) – is located in the southern portion of the site. Wetland F is located entirely on-site. During the on-site field visit conducted on 8-OCT-2020, the entire perimeter of the wetland was walked and was observed to be surrounded by upland and a direct hydrological connection was not observed from this wetland to a Relatively Permanent Water (RPW) or a Non-relatively Permanent Water (NRPW). Wetland F is 192 linear feet from the nearest RPW, which is Stream 2A that was identified in the LRH-2014-00051 preliminary jurisdictional determination. Based upon site visit observation, it has been determined that Wetland F is an isolated wetland which is not adjacent to or directly abutting a RPW or NRPW and cannot be used by interstate or foreign travelers for recreational or other purposes; or from which fish or shellfish are or could be taken and sold in interstate or foreign commerce; or which are used or could be used for industrial purposes by industries in interstate commerce.**

**Wetland G (0.38-acre emergent and 0.15-acre forested) – is located in the southern portion of the site. Wetland G is located entirely on-site. During the on-site field visit conducted on 8-OCT-2020, the entire perimeter of the wetland was walked and was observed to be surrounded by upland and a direct hydrological connection was not observed from this wetland to a Relatively Permanent Water (RPW) or a Non-relatively Permanent Water (NRPW). Wetland G is 696 linear feet from the nearest RPW, which is Stream 2A that was identified in the LRH-2014-00051 preliminary jurisdictional determination. Based upon site visit observation, it has been determined that Wetland G is an isolated wetland which is not adjacent to or directly abutting a RPW or NRPW and cannot be used by interstate or foreign travelers for recreational or other purposes; or from which fish or shellfish are or could be taken and sold in interstate or foreign commerce; or which are used or could be used for industrial purposes by industries in interstate commerce.**

**Pond 1 (0.08-acre) - is located in the southern portion of the site. A culvert from the pond outlets into Wetland F, which is an isolated wetland. Pond 1 is surrounded entirely by upland and a direct hydrological connection could not be established to a RPW or NRPW. A review of aerial imagery from Google Earth Pro shows that the pond was excavated between 16-JUN-2006 and 31-MAY-2007. The pond was constructed in an area mapped as Mahoning silt loam soils (MgB, 2 to 6 percent slopes) which are only 5% hydric (Web Soil Survey). Based on available aerial imagery (Google Earth, 28-FEB-2006) there was a probable wetland at this location. Any wetland present below the ordinary high water mark of Pond 1 do not meet the wetland criteria described in the Corps of Engineers Wetland Delineation Manual - January 2007 and supporting Northeast/Northcentral Supplement Manual. Pond 1 is not a TNW, including territorial seas. Pond 1 is not a wetland that is adjacent to a TNWs, a wetland that directly abuts a RPWs that flow directly or indirectly into TNWs, a wetland adjacent to, but not directly abutting RPWs that flow directly or indirectly into TNWs, or a wetland adjacent to NRPWs that flow directly or indirectly into TNWs. Pond 1 lacks an ordinary high water mark and a stream bed and is not a RPW that flows directly and indirectly into TNWs. Also, Pond 1 is not an impoundment of a jurisdictional waters. There is no evidence that Pond 1 was excavated in a RPWs or NRPWs, and it not an impoundment of a jurisdictional waters. Pond 1 is not an isolated (interstate or interstate waters, including isolated wetlands. Pond 1 does not meet any of the waters of the United States identified in Section II A or B.**
