C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

F. NON-JURISDICTIONAL WATERS, INCLUDING WETLANDS (CHECK ALL THAT APPLY):

Wetland C – 0.01-acre on-site. Wetland C is an emergent wetland located approximately in the center of the delineation site. Wetland C is located 110 linear feet to the north of Stream 2. A review of aerial imagery from Google Earth Pro and Eagleview ConnectExplorer shows that Wetland C is surrounded by upland and does not flow into Stream 2. Eagleview ConnectExplorer aerial images taken on 4/10/2007, 3/31/2011, 11/13/2013, 11/22/2016 and 12/29/2020 does not show evidence of water flow from Wetland C to Stream 2. Wetland C does not abut or have a continuous surface connection of Stream 2, is not physically separated from Stream 2 by dikes, barriers, berms or dunes. Based upon a review of aerial imagery, it has been determined that Wetland C is an isolated wetland which is not adjacent to or directly abutting a RPW or NRPW and cannot be used by interstate and foreign travelers for recreational or other purposes; or from which fish or shellfish are or could be taken and sold in interstate or foreign commerce; or which are used or could be used for industrial purposes by industries and interstate commerce.

Ditch 2 – 112 lf on-site. Ditch 2 is oriented in a south to north direction. A review of aerial imagery from Google Earth Pro and Eagleview ConnectExplorer shows that Ditch 2 is surrounded by upland and does not flow into Stream 1 or Stream 2. Eagleview ConnectExplorer aerial images taken on 4/10/2007, 3/31/2011, 11/13/2013, 11/22/2016 and 12/29/2020 does not show evidence of water flow in Ditch 2. SP9 was a wetland data point taken near Ditch 2. At this data point, a soil pit was dug to a depth of 16-inches. The soil profile description taken at SP9 was 10YR2/2 100% at 0 to 3-inches, and 10YR4/4 100% at 3 to 16-inches, indicating non-hydric soils. No wetland hydrology indicators were observed at SP9. The vegetation at SP9 did indicate the presence of wetland vegetation. Based on the review of wetland sample point taken near Ditch 2, aerial imagery and USGS topographic maps, it has been determined that Ditch 2 does not meet the definition of wetland and was constructed in upland, drains only upland and has less than relatively permanent flow. It has also been determined that Ditch 3 was excavated wholly in and draining only uplands and does not carry a relatively permanent flow of water, does not contribute water directly or indirectly to a downstream TNW. It has also been determined that Ditch 2 does not meet any of the CWA Section 404 Waters of the U.S. within Clean Water Act jurisdiction (as defined by 33 CFRA part 328).

Ditch 3 – 523 lf on-site. Ditch 3 is oriented in a south to north direction. A review of aerial imagery from Google Earth Pro and Eagleview ConnectExplorer shows that Ditch 3 is surrounded by upland and does not flow into either Ketcham Ditch or Stream 2. Eagleview ConnectExplorer aerial images taken on 4/10/2007, 3/31/2011, 11/13/2013, 11/22/2016 and 12/29/2020 does not show evidence of water flow in Ditch 3. A review of historicaerial.com shows that Ditch 3 has been present on the site since at least 1955. A review of historic aerials from 1955, 1963, 1964, 1983 to present date does not show wetland signatures in the vicinity of Ditch 3. SP10 was a wetland data point taken within Ditch 3. At this data point, a soil pit was dug to a depth of 21-inches. The soil profile description taken at SP10 was 10YR2/2 100%, indicating non-hydric soils. No wetland hydrology indicators were observed at SP10 and the vegetation at the sample point was dominated by upland species. SP12 was also taken close to Ditch 2. At this data point, a soil pit was dug to a depth of 20-inches. The soil profile description taken at SP12 was 10YR3/2 100%, indicating non-hydric soils. No wetland hydrology indicators were observed at SP12 and the vegetation at the sample point was dominated by upland species. Based on the review of wetland sample points taken near Ditch 3, aerial imagery and USGS topographic maps, it has been determined that Ditch 3 does not meet the definition of wetland and was constructed in upland, drains only upland and has less than relatively permanent flow. It has also been determined that Ditch 3 was excavated wholly in and draining only uplands and does not carry a relatively permanent flow of water, does not contribute water directly or indirectly to a downstream TNW.
