### C. SIGNIFICANT NEXUS DETERMINATION

**A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.**

- Other: (explain, if not covered above): **The review area (approximately 170.17-acres in size) contains Wetlands 2 (0.92-acre;PFO), 3 (0.09-acre;PFO), and 5 (0.41-acre;PFO), which have been determined to be isolated waters completely surrounded by uplands. Wetlands 2, 3, and 5 are isolated, intrastate wetlands and have no interstate or foreign commerce nexus.**

During a November 8, 2021 site visit of the review area performed by U.S. Army Corps of Engineers staff and J. Celeste from Earth Dimensions, Inc. the wetland boundaries for each of these wetlands (Wetlands 2, 3, and 5) were walked entirely around each boundary, which confirmed that these three wetlands are surrounded wholly by upland and there are no conveyances that would suggest a hydrologic connection. Wetlands 2 and 5 were determined to be connected with a culvert during the site visit, having a hydrologic connection to each other. Wetlands 2 and 5 are not within a floodplain of any streams or rivers, and thus, do not have any inundations by another regulated water. The nearest RPW is approximately 300 linear feet to the south.

A review of in-office resources, including the USGS topographical quadrangle for NY - Clarence and aerial/oblique imagery suggested that a stream flowed through this area, but it was apparent during the site visit that flow from the west drained into this area and did not extend beyond the western boundary of Wetland 2. Based on the site visit, wetland 2 is a depressional feature with no hydrologic connection in the area suggested by the USGS map. Additionally, Wetlands 2 and 5 do not drain or connect to Wetland 1 (documented on LRB-2021-00657 Preliminary JD, dated April 20, 2022) located to the south because the topography increases to the south of wetlands 2 and 5 before it declines into Wetland 1.

Wetland 3 is a depressional feature that is completely surrounded by uplands. Similar to Wetlands 2 and 5, the waters/wetlands delineation report and the site visit determined no hydrological connectivity to Wetland 1, nor 2 and 5 because of the incline in topography in the surrounding area of the wetlands boundaries. Wetland 3 is located approximately 120 linear feet north of the nearest RPW, is not located within a floodplain, and does not receive or exchange flood waters from any regulated waters.

Based on the above information, these wetlands do not meet wetland adjacency criteria. Due to the topography of the site, the presence of a shallow subsurface flow connection for any of the wetlands is unlikely.

Therefore the overall review of in-office resources, including aerial photographs, the on-site visits, and information contained within the submitted waters and wetlands delineation report, has resulted in the determination that Wetlands 2, 3, and 5 are outside Department of the Army jurisdiction because they are isolated, intrastate wetlands which have no interstate or foreign commercial nexus.
