C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

- Other: (explain, if not covered above): **Observations made during the site visit on Oct. 12, 2021 indicate Wetlands 2 and 11 are located in shallow depressions with no potential for a surface water or shallow subsurface connection to an RPW. The boundaries were reviewed in their entirety and found to be geographically isolated within surrounding dry land soils. The Web Soil Survey indicates the wetlands (including Wetland 13 described below) are established in Niagara silt loam, 0 to 3 percent slopes with a hydric rating of 4 (1-32% range). The presence of a shallow subsurface flow connection for the wetland is very unlikely due to topography and the distance to the nearest tributary. The wetlands are within 150 feet of an off-site, man-made ditch (RPW). However, material sidecast from the excavation of that feature creates an artificial berm that does not allow for a direct hydrologic surface connection between the wetlands and the water (33 CFR 328.3(c)(1)(iv)).**

Wetlands 12, 13, & 14 are shallow isolated depressions located in old access roads with no potential for surface water connection. The boundaries were reviewed in their entirety and found to be geographically isolated within surrounding dry land soils. The Web Soil Survey indicates Wetlands 12 & 14 are established in Canandaigua silt loam with a hydric rating of 96% (66-99% range). The presence of a shallow subsurface flow connection for the wetland is very unlikely due to topography and the distance to the nearest tributary. The wetlands are approximately 200 feet or more away from the off-site, man-made RPW. However, material sidecast from the excavation of that feature creates an artificial berm that does not allow for a direct hydrologic surface connection between the wetlands and the water (33 CFR 328.3(c)(1)(iv)).

Wetlands 12, 13, & 14 are shallow isolated depressions located in old access roads with no potential for surface water connection. The boundaries were reviewed in their entirety and found to be geographically isolated within surrounding dry land soils. The Web Soil Survey indicates Wetlands 12 & 14 are established in Canandaigua silt loam with a hydric rating of 96% (66-99% range). The presence of a shallow subsurface flow connection for the wetland is very unlikely due to topography and the distance to the nearest tributary. The wetlands are approximately 200 feet or more away from the off-site, man-made RPW. However, material sidecast from the excavation of that feature creates an artificial berm that does not allow for a direct hydrologic surface connection between the wetlands and the water (33 CFR 328.3(c)(1)(iv)).
