C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

The pond appears on aerals dating back to 1952, when the site appeared to be an active farm. Over the years, the pond changed in size and was used as a back drop to a firing range prior to being expanded into a stormwater pond that drains into the city sewer system in the south end. A review of the aerals from 1952 to present, do not indicate that the pond was created inline with an existing stream and has been an isolated pond since atleast 1952. Based on the ponds osition in the landscape, nearly on the boarder of 2 watersheds, it is likley that the pond has always been isolated and was not constructed in an inline stream. The pond was created in Udorthents - sanitary landfill (Uf) soils, which is further indication that no jurisdictional streams or wetlands were on sie prior to the pond creation. The USACE visit on 04/28/2022 confirmed that the pond is offline with a wetland fringe and that it drains, via a culvert that connects to the city storm sewer system. Based on this information, the pond does not meet the criteria as a water of the US as classified in the preamble of the November 14, 1986 federal register.

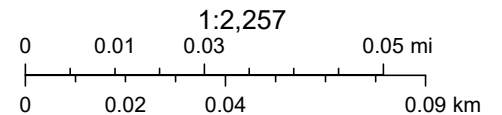
