C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Wetland B is an isolated, intrastate wetland and no interstate or foreign commerce nexus exists.**

During a April 29, 2022 site visit of the review area performed by U.S. Army Corps of Engineers staff and the wetland delineators, the boundary of Wetland B was walked entirely around confirming that the area was wholly surrounded by upland and there are no conveyances that would suggest a surface hydrologic connection to another Water of the U.S. The nearest RPW is located approximately 60 linear feet to the east of Wetland B, and is known as Foster Brook. Historical filling has occurred within the review area to the west of the wetland. A previous Approved Jurisdictional Determination, dated January 18, 2011 documented wetland B as Wetland A, which was larger (0.15-acre) and partially filled, stating that the surface water drained as overland sheetflow into Foster Brook as documented with the following statement: "Wetland A now drains to the north via overland sheetflow which is influenced by the on-site topography that carries surface water directly into Foster Brook." However during the April 29, 2022 site visit, there was no evidence of overland sheetflow leaving the wetland to the north or any other direction, which was supported by the in-office resource review and submitted wetland delineation report. To be sure, the streambank of Foster Brook was walked to see if any surface water or subsurface water from that direction was outleting into Foster Brook, but the topography increased from Wetland B to the east toward Foster Brook and there was no observations of water discharging along the streambank adjacent to Wetland B. Further, due to topography and distance to the nearest tributary, the presence of a shallow subsurface flow connection for the wetland is very unlikely. No connection could be verified. The FEMA floodplain maps note that the wetland is zone AE, but Foster Brook's banks are approximately 5-6 feet higher than the streambed and there was no evidence observed of any water being exchanged during flooding from Foster Brook to Wetland B.

A review of in-office resources, including the USGS topographical quadrangle for NY - Buffalo SE, the U.S. Fish and Wildlife Service National Wetland Inventory, NRCS web soil survey, and aerial/oblique imagery indicated that there were wetlands in this area, along with a stream (Foster Brook) nearby. The in-office resource review of aerial/oblique imagery and a review of the administrative record, also support the extensive disturbance of this site that has altered hydrology of the site over time.

Therefore considering all of the above information, Wetland B does not meet the wetland adjacency criteria and has been determined to be outside Department of the Army jurisdiction because it is an isolated, intrastate wetland having no interstate or foreign commerce nexus.
