This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. ### C. SIGNIFICANT NEXUS DETERMINATION

**A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.**

**F. NON-JURISDICTIONAL WATERS, INCLUDING WETLANDS (CHECK ALL THAT APPLY):**

- Other: (explain, if not covered above): **On November 5, 2020 the USACE walked the entire perimeter of Wetlands 1 (0.51 acres), Wetland 2 (0.05 acres) and Wetland 3 (0.36 acres) to determine if they had a downstream connection. The wetlands are isolated from the unnamed tributary located on site and are isolated from any other potential off-site waters. Wetland 1 is approximately 500' from the on-site tributary and approximately 260' and further from other sections of that tributary off-site. Wetland 1 continues east past the property boundary. It was determined that there is no evidence that Wetland 1 is contiguous to Tributary 1 off site to the east. There is no evidence on site, or within resources including soils and topography to support Wetland 1 exchanges surface or subsurface hydrology with the Niles Avenue ditch or Tributary 1. Tributary 1 is being assessed using a preliminary jurisdictional determination. Wetland 2 is approximately 400' from the on-site tributary. Wetland 3 is approximately 90' from the one-site tributary. It was determined that there is no clear surface water connections existing between Wetlands 1, 2, and 3 and any other water of the United States. Due to landscape, soils, topography and distances to the nearest tributary, the potential presence of a shallow subsurface flow connection from the wetlands is not supported. Wetlands 1, 2 and 3 were found to be isolated, intrastate, non-navigable wetlands which have no interstate or foreign commerce nexus and therefore are not subject to federal jurisdiction. Based on this information it was determined that the wetland does not meet adjacency criteria.**
