C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Wetland 2- 0.012-acres on-site. Wetland 2 is an emergent wetland that is in the west-central part of the delineation area. Wetland 2 is located 157 linear feet to the south of Stream 1. A review of aerial imagery from Google Earth Pro and Eagleview Connect Explorer aerial images taken on 04/02/2022, 04/27/2019, 04/14/2017, 04/25/2015 does not show evidence of water flow from Wetland 2 to Stream 1. Wetland 2 does not abut or has a continuous surface connection of Stream 1, is not physically separated from Stream 1 by dikes, barriers, berms or dunes. Based upon observations noted during an on-site field visit and a review of aerial imagery, it has been determined that Wetland 2 is an isolated wetland which is not adjacent to or directly abutting a RPW or Non-RPW and cannot be used by interstate and foreign travelers for recreational or other purposes; or from which fish or shellfish are or could be taken and sold in interstate or foreign commerce; or which are used or could be used for industrial purposes by industries and interstate commerce.

Wetland 3- 0.226-acres on-site. Wetland 3 is a forested wetland that is in the southern part of the delineation area. Wetland 3 is located 426 linear feet to the south of Stream 1. There is no roadside ditch or stormwater sewer located along Enterprise Parkway in which water from Wetland 3 can flow into. A review of aerial imagery from Google Earth Pro and Eagleview Connect Explorer aerial images taken on 04/02/2022, 04/27/2019, 04/14/2017, 04/25/2015 does not show evidence of water flow from Wetland 3 to Stream 1. Wetland 3 does not abut or have a continuous surface connection of Stream 1, is not physically separated from Stream 1 by dikes, barriers, berms or dunes. Based upon observations noted during an on-site field visit and a review of aerial imagery, it has been determined that Wetland 3 is an isolated wetland which is not adjacent to or directly abutting a RPW or Non-RPW and cannot be used by interstate and foreign travelers for recreational or other purposes; or from which fish or shellfish are or could be taken and sold in interstate or foreign commerce; or which are used or could be used for industrial purposes by industries and interstate commerce.

Wetland 4- 0.0.141-acres on-site. Wetland 4 is a forested wetland that is in the southern part of the delineation area. Wetland 4 is located 805 linear feet to the south of Stream 1. There is no roadside ditch or stormwater sewer located along Enterprise Parkway in which water from Wetland 4 can flow into. A review of aerial imagery from Google Earth Pro and Eagleview Connect Explorer aerial images taken on 04/02/2022, 04/27/2019, 04/14/2017, 04/25/2015 does not show evidence of water flow from Wetland 4 to Stream 1. Wetland 4 does not abut or have a continuous surface connection of Stream 1, is not physically separated from Stream 1 by dikes, barriers, berms or dunes. Based upon observations noted during an on-site field visit and a review of aerial imagery, it has been determined that Wetland 4 is an isolated wetland which is not adjacent to or directly abutting a RPW or Non-RPW and cannot be used by interstate and foreign travelers for recreational or other purposes; or from which fish or shellfish are or could be taken and sold in interstate or foreign commerce; or which are used or could be used for industrial purposes by industries and interstate commerce.

Wetland 5- 0.204-acres on-site. Wetland 5 is an emergent wetland that is in the southern part of the delineation area. Wetland 5 is located 642 linear feet to the south of Stream 1. There is no roadside ditch or stormwater sewer located along Enterprise Parkway in which water from Wetland 5 can flow into. A review of aerial imagery from Google Earth Pro and Eagleview Connect Explorer aerial images taken on 04/02/2022, 04/27/2019, 04/14/2017, 04/25/2015 does not show evidence of water flow from Wetland 5 to Stream 1. Wetland 5 does not abut or have a continuous surface connection of Stream 1, is not physically separated from Stream 1 by dikes, barriers, berms or dunes. Based upon observations noted during an on-site field visit and a review of aerial imagery, it has been determined that Wetland 5 is an isolated wetland which is not adjacent to or directly abutting a RPW or Non-RPW and cannot be used by interstate and foreign travelers for recreational or other purposes; or from which fish or shellfish are or could be taken and sold in interstate or foreign commerce; or which are used or could be used for industrial purposes by industries and interstate commerce.
