The subject wetlands are depressional features that occur within forested areas or along the edges of agricultural fields that are densely vegetated. Boundaries for each wetland were confirmed during the USACE site visit on 06/02/2022. No connectivity to any downstream conveyance for any of the wetlands was observed.

W-BTF-9    PFO    3.94 acres      (Highlighted in yellow on Sheet 2 of 3)

This large, forested wetland is confined by topography. Standing water and diverse herbaceous layer was observed.

C. **SIGNIFICANT NEXUS DETERMINATION**

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

The subject wetlands are depression features that occur within forested areas or along the edges of agricultural fields that are densely vegetated. Boundaries for each wetland were confirmed during the USACE site visit on 06/02/2022. No connectivity to any downstream conveyance for any of the wetlands was observed.

**W-BTF-9** PF0 3.94 acres (Highlighted in yellow on Sheet 2 of 3)

This large, forested wetland is confined by topography. Standing water and diverse herbaceous layer was observed. According to the Web Soil Survey, mapped soils are Alden mucky silt loam, till substratum which has a hydric rating of 88. The wetland is depicted on the NWI map.

Using the Google Earth measuring tool, the distance from W-BTF-9 to the nearest conveyance is approximately 1,363 feet to the unnamed tributary to Mud Pond to the west and/or approximately 910 feet to S-BTF-7A to the east, with undulating topography, agricultural fields and forested woodlots impeding connectivity in either direction.

**W-BTF-14** PEM 0.94 (Highlighted in yellow on Sheet 2 of 3)

This wetland is confined by topography and consists of reed canary grass at the edge of the agriculture field that extends along the densely vegetated forest perimeter. According to the Web Soil Survey, this wetland occurs in soils mapped as Madalin silt loam, sandy subsoil variant, which has a hydric rating of 95. The wetland is not depicted on the NWI map.

Using the Google Earth measuring tool, the distance from W-BTF-14 to the nearest conveyance is approximately the same as W-BTF-9 above (1,363 feet to the unnamed tributary to Mud Pond to the west and/or approximately 910 feet to S-BTF-7A to the east), with undulating topography, agricultural fields and forested woodlots impeding connectivity in either direction.

**W-BTF-15** PFO 0.23 acre (Highlighted in yellow on Sheet 3 of 3).

This wetland is moderately deep depression in a forested area between farm fields. The area is littered with large, uprooted trees and slash cleared from upland areas many years ago. According to the Web Soil Survey, this wetland occurs within Riga and Lairdsville silt loams, 2 to 6 percent slopes which has a hydric rating of 0. The wetland is not depicted on the NWI map.

Using the Google Earth measuring tool, the distance from W-BTF-15 to the nearest conveyance (Stream S-BTF-7A) is approximately 180 feet with topographic confinement as the impediment to connectivity. Regardless, Stream S-BTF-7A was found to be isolated as determined in the previous approved JD dated 12/14/2021.

Explain: The USACE site visit on 06/02/2022, found all three wetlands to be isolated, intrastate wetlands with no interstate or foreign commerce nexus and which do not meet the wetland adjacency criteria. Further, due to topography and distance to the nearest tributary for each of the wetlands, the presence of a shallow subsurface flow connection is very unlikely.
