Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. **Pond A (0.16 acre) and Wetlands B (0.08 acre - PFO), and C (0.09 acre - PFO) are outside Department of the Army jurisdiction as they do not meet the criteria for a jurisdictional water of the United States according to 33 CFR Part 328.3(a)(1-7) as follows:**

Pond A (0.16 acre – Open Water) is characteristic of an open water pond, which is approximately two-three feet deep and excavated into the bedrock as evidenced by the abrupt banks and exposed rock. The water body does not have any subaquatic vegetation and has a few silky dogwood (*Cornus amomum*) shrubs along the periphery. There is no evidence of a surface water connection to downstream waters. The feature was excavated wholly in an upland area. The mapped soil type for this area is Farmington loam (Fa) 2 to 8 percent slopes and is not classified as a hydric soil.

This waterbody is approximately 485-feet from the nearest conveyance described above, and there is no evidence that flow from **Pond A** reaches this conveyance. The hydrology source for this open water body is likely groundwater and precipitation influenced. It may provide limited habitat for amphibian species and aquatic macroinvertebrates; however, the vertical bedrock banks are 2-3 feet high prohibiting its use as a watering or foraging source for common mammal species. The feature may provide limited habitat for waterfowl foraging, but this has not been observed. Due to the limited habitat function of Pond A, there is little likelihood that it contributes ecological or wildlife values to Mudd Creek.

Wetland B (0.08 acre PFO) – approximately 260-feet from the nearest conveyance

Wetland C (0.09 acre PFO) – approximately 265 feet from the nearest conveyance

These are small surface excavations exhibiting exposed rock. These shallow wetlands had 12-18-inches of standing water at the time of the delineation on March 18, 2013, but were dry at the time of the jurisdictional determination site visit on October 28, 2013. Dominant vegetation is an understory of silky dogwood shrubs. Both wetlands are bordered by low berms suggesting that the excavated material was sidecast adjacent to the shallow excavations. The features were excavated wholly in an upland area that is shallow to bedrock. The mapped soil type in these areas is Farmington loam (Fa) 2 to 8 percent slopes and is not classified as a hydric soil. Because of the shallow depth to bedrock, the soil profile could not be obtained deeper than 6-inches.

There is no evidence that flow from Pond A and Wetlands B and C reach the concrete roadside conveyance. The hydrology source for these wetlands is likely influenced by groundwater and precipitation, to a lesser extent. They may provide limited habitat for amphibian species, aquatic macroinvertebrates, and mammal species typical of the area. Due to the limited habitat function of these aquatic resources, there is little likelihood that they contribute ecological or wildlife values to Mudd Creek.

Based on the above information, adjacency to downstream waters via reasonably close proximity, direct, or shallow sub-surface connection to Mudd Creek or other waters is not demonstrated. Therefore, it has been determined that Pond A and Wetlands B and C are isolated depressional waterbodies with no ecological interconnection with jurisdictional waters.

If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
